RECITALS

WHEREAS, on or about June 20, 2018, City and Company entered into that certain Services Agreement to furnish all labor, materials, and equipment for and perform the work of generating the Riverside Activity Guide ("Services"); and

WHEREAS, on or about June 20, 2021, City and Company entered into that certain First Amendment to Services Agreement to extend the term of the Agreement and add additional compensation ("First Amendment"); and

WHEREAS, Paragraph 2 of the Agreement states that the term was for a three-year period ending June 19, 2021, and that City and Company shall have the right to extend the Agreement for two (2) additional one-year periods if mutually agreed upon in writing; and

WHEREAS, the City and Company desire to extend the Agreement for the one-year period beginning June 20, 2022, and ending June 19, 2023 ("Extended Term"); and

WHEREAS, Paragraph 22 of the Agreement states that the Agreement may be modified or amended only by a written agreement and/or change order executed by the Company and City; and

WHEREAS, City and Company desire by this Second Amendment to establish the compensation to be paid by City to Company during the Extended Term in the amount of Two Hundred Thirteen Thousand Two Hundred Seventeen Dollars and Thirty-One Cents (\$213,217.31).

NOW, THEREFORE, in consideration of the foregoing recitals which are incorporated herein by this reference, City and Company agree as follows:

- 1. The Agreement term shall hereby be extended for the one-year period beginning June 20, 2022, and ending June 19, 2023.
- 2. Paragraph 3 of the Agreement, Compensation, is hereby amended to add the following:

"During the extended period beginning June 20, 2022, and ending June 19, 2023, Company shall perform the Services under this Agreement for the annual sum of Two Hundred Thirteen Thousand Two Hundred Seventeen Dollars and Thirty-One Cents (\$213,217.31)."

3. All other terms and conditions of the Agreement between the parties, which are not inconsistent with the terms of this Second Amendment, shall remain in full force and effect as if fully set forth herein.
