RE: 2022 AMMRF Rate Adjustments, New Commingled Green Rate

Dear Mr. Mustafa:

Enclosed are the Refuse, Green Waste, and SSO Food Waste tip fee adjustments for the Robert A. Nelson Transfer Station. Also included is the Residential Recycling Processing Fee adjustment. These rates include costs adjustments related to the Consumer Price Index (CPI) as well as landfill disposal tip fees as approved by the Riverside County Board of Supervisors and are adjusted per the requirements of Section 6 of our Agreement for Transfer Services.

The City's pilot "commingled" green/food residential recycling program has proven to be successful. During the pilot period, Burrtec provided this service at no additional cost over the Green Waste rate. The Commingled Green processing includes separation of the food along with other contamination. The food is then processed for composting and/or anaerobic digestion. Greenwaste is ground and screened for composting. To provide these additional services, Burrtec has made significant investments into a Covered Aerated Static Pile (CASP) composting system and a new Bio-Separator operation at the Robert A. Nelson Transfer Station. These capital investments, along with a more labor-intensive processing operation, have resulted in the new Commingled Green rate of \$98.20 per ton.
