## **BACKGROUND**

1. 1950 – Riverside Levees 1 and 2 construction authorized under the Federal Flood Control Act
2. 1956 – County Board of Supervisors Resolution No. 265 and Resolution No. 293 guaranteed local cooperation
3. 1958 – 1959, U.S. Army Corps of Engineers(USACE)constructed levees and transferred maintenance responsibility to Riverside County Flood Control and Water Conservation District (District)

## BACKGROUND CONTINUED

4. January 2013 – Riverside levees 1 and 2 declared “Unacceptable” by the U.S. Army Corps of Engineers
  - a. Immediate corrective action needed
  - b. USACE directs District to repair levees
  - c. USACE secured funding for rehabilitation work

Levee 1:

1. Located in the County of Riverside – West Bank
2. Runs between the City of Riverside to City of Jurupa Valley
3. Approximately 2.4 miles

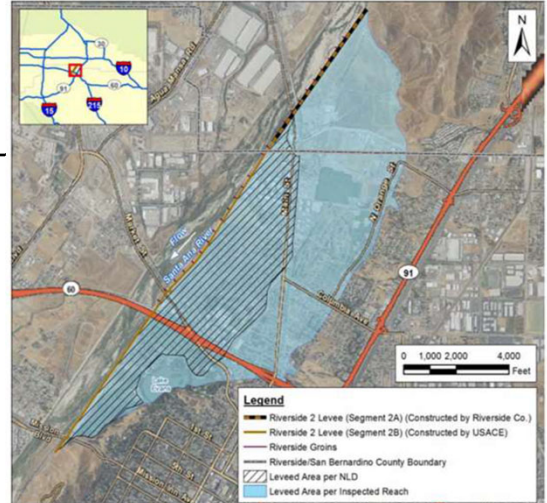

2. Runs between the City of Riverside to City of Colton
3. Approximately 2.7 miles

4. Proposed Right of Entry and Temporary Construction Easement for a 54-month term, total compensation \$2,606,202



## RECOMMENDATIONS

### That the City Council:

1. Approve the Right of Entry and Temporary Construction Easement Agreement with Riverside County Flood Control and Water Conservation District for a staging area on a portion of City-owned property, Assessor's Parcel No. 0277-022-75, to facilitate construction and implementation of the Right and Left Levee Diversion known as the Riverside Levee Santa Ana River Stabilization Project for a term from June 1, 2022, to December 31, 2026, for total compensation of \$2,606,202 to the City; and
2. Authorize the City Manager, or his designee, to execute the Right of Entry and Temporary Construction Easement Agreement, including making minor, non-substantive changes, and sign all documents and instruments necessary to complete the transaction.
