27	contained in the Contract shown in the Procedural Guide; and

1	5. Appoints the Parks, Recreation, and Community Services Director as agent to conduct all
2	negotiations, execute and submit all documents, including, but not limited to Applications,
3	agreements, amendments, payment requests and so on, which may be necessary for the
4	completion of the Project.
5	6. Agrees to comply with all applicable federal, state and local laws, ordinances, rules,
6	regulations and guidelines.
