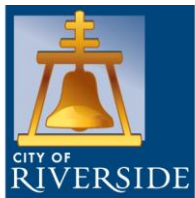

Ryan Railsback from the Riverside Police Department Community Services Bureau Media Unit gave a presentation on California Assembly Bill 1475 and gave an overview of the laws and restrictions associated with the use of booking photos on law enforcement social media platforms.

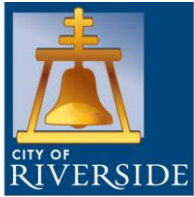

### UPDATES FROM THE CITY MANAGER'S OFFICE

Lee Withers reported the following City Council items associated with RPD:

April 19, 2022:

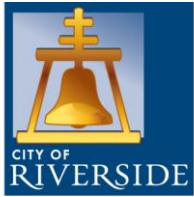
- (1) Purchase and Sale Agreement with the County of Riverside in the amount of \$3,100,00 plus misc. title, escrow and related costs for the Downtown Police Headquarters.
- (2) Resolution to accept California Highway Patrol's 2022/23 Cannabis Tax Fund Grant Program Award in the amount of \$111,003.46 for education, prevention, and enforcement of laws related to driving under the influence for the period of July 1, 2022, through June 30, 2033.

May 3, 2022:

- (1) Appropriation of \$24,800 for participation in the US Dept of Justice United States Marshals Service Regional Fugitive Task Force
- (2) Accept AKC Reunite Adopt a K-9 Matching grant in the amount of \$7,500 for police service dog, training, and equipment.

May 10, 2022:

- (1) Purchase of 45 Avon Gear Air Purifying System Masks and accessories from Safeware in the amount of \$69,353.24
- (2) Receive \$106,667.66 in grant funds from the Dept of Health and Human Services Substance Abuse and Mental Health Services Administration for training and administration of the Federal Food, Drug, and Cosmetic Act
