WHEREAS, City and Contractor entered into that certain First Agreement for Landscape and General Outside Maintenance Services for North Quadrant Parkways and Medians (RFP No. 1907) ("Agreement") dated May 4, 2022 ("First Amendment") to increase the compensation and extend the term; and

WHEREAS, City and Contractor desire to increase the contract price under the Agreement in the amount of One Hundred Fourteen Thousand Eight Hundred Thirty-Three Dollars (\$114,833), for the period of July 1, 2021 to June 30, 2022.

NOW, THEREFORE, in consideration of the foregoing recitals, which are incorporated herein by this reference, City and Contractor mutually agree as follows:

- 1. Paragraph 3, "Compensation," is increased in the amount of One Hundred Fourteen Thousand Eight Hundred Thirty-Three Dollars (\$114,833) for revised total of Seven Hundred Ten Thousand Dollars (\$710,000), for the period of July 1, 2021, to June 30, 2022.
- 2. All terms and conditions of the Agreement not inconsistent herewith, shall remain in full force and effect and are hereby incorporated by reference into this Second Amendment as though set forth in full herein.
