

**SECOND AMENDMENT TO  
ATTORNEY SERVICES AGREEMENT**

THIS SECOND AMENDMENT TO ATTORNEY SERVICES AGREEMENT ("Second Amendment") is made and entered into this 9th day of May, 2022, by and between the CITY OF RIVERSIDE, a California charter city and municipal corporation ("City"), and LEWIS BRISBOIS BISGAARD & SMITH LLP, a California Limited Liability Partnership ("Law Firm"), with respect to the following:

**RECITALS**

A. The City and Law Firm entered into that certain Attorney Services Agreement dated November 20, 2015 ("Agreement"), and placed Law Firm on the City's approved outside counsel panel.

B. On or about May 15, 2019, the City and Law Firm entered into the First Amendment to Attorney Services Agreement, extending the term of the Agreement to November 20, 2021.

C. The City desires to continue to have Law Firm included on the City's approved Outside Counsel Panel and to extend the term of the Agreement to June 30, 2023.

NOW, THEREFORE, incorporating the recitals set out above, the parties hereto mutually agree to the following amendment to the Agreement.

1. The term of the Agreement is hereby extended to June 30, 2023.
2. Exhibit "A" of the Agreement, setting forth the address of the Law Firm and the hourly rates, is hereby amended and replaced with Exhibit "A-2," attached hereto and incorporated herein by this reference.
3. All other terms and conditions of the Agreement between the parties, which are not inconsistent with the terms of this Second Amendment, shall remain in full force and effect as if fully set forth herein.


