### 3. EXECUTIVE DIRECTOR'S REPORT

#### A. Working Group Update

Mr. Webster introduced SCPPA'S new Policy Advocate, Elisabeth De Jong, who will be working closely with SCPPA's Sacramento Government Affairs team. Ms. De Jong briefly introduced herself to the Board and expressed how excited she was to join SCPPA. Ms. Martin shared with the Board a recap of the first Legal Working Group meeting. SCPPA legal expressed the intent to hold Legal Working Group meetings quarterly.

Mr. Webster gave an update on the SCPPA 2022 Annual Conference that included registration, panel line up, and the events leading up to the Annual Conference.

Mr. Webster reported to the Board that the department of commerce has initiated an investigation that may result in increased Tariffs for panels that are effecting commercial operation rates, pricing, and impacting proposals and projects in which SCPPA is in active negotiations with. Mr. Webster reported to the Board that we have seen an increase of 13% to 17% price for projects on account of the potential tariffs and the unpredictability surrounding whether will be a short term or long term issue..

##### **C. Federal Issues Update**


