SUBJECT: GIFT FUND DONATIONS FROM JUNE 2022 IN THE AMOUNT OF \$172,123.56

ISSUE:

Accept and recommend that the City Council approve gift fund donations from June 2022 in the amount of \$172,123.56.

RECOMMENDATION:

That the Board of Library Trustees accept and recommend that the City Council approve gift fund donations from June 2022 in the amount of \$172,123.56.

BACKGROUND:

The Library receives monetary donations from various groups, individuals and foundations. These funds are used by the library to supplement regular funding from the City. Pursuant to the City Charter Section 808(f) the Board of Library Trustees has the power and duty to accept money donated to the City for Library purposes, subject to the approval of the City Council. The donated gift funds received are provided in the following table.

STRATEGIC PLAN ALIGNMENT:

- 3. **Fiscal Responsibility** Through City Charter Section 808 (f), the Board of Library Trustees shall have the power and duty to accept money, personal property or real estate donated to the City for library purposes, subject to the approval of the City Council.
- 4. **Innovation** This item aligns with Innovation in future partnership with the Community Foundation, Friends of the Library, Riverside Public Library Foundation and other donors.
- 5. **Sustainability & Resiliency** This assists the Library with Sustainability & Resiliency by potentially providing fund development opportunity.

FISCAL IMPACT:

The fiscal impact associated with the acceptance of gift fund donations is an increase to the Special Deposits Fund Library Systems accounts in the amount of \$172,123.56 to be expended in the near future on Library resource items.
