SUBJECT: SUMMARY OF SECURITY/INCIDENT REPORTS

ISSUE:

Receive a summary of security/incident reports from May, June and July 2022.

RECOMMENDATION:

That the Board of Library Trustees receive and file the summary of security/incident reports from May, June and July 2022.

BACKGROUND:

The Riverside Public Library has established Rules of Library Conduct Identified and Prohibited by the Riverside Municipal Code Section 9.75 for successful running of its facilities, to maintain an appropriate library environment, and to ensure customers enjoy their Library visits. Library employees, in consultation with their supervisor, are authorized to issue warning and exclusion notices for violations to the Rules of Library Conduct (attached).

An itemized summary below provides a brief description of the incidents, warning and exclusion notices that occurred at all Riverside Public Library locations in May, June and July 2022.

- 5/26/22 Incident of individual using drugs who was asked to leave the library. Exclusion notice issued for 180 days.*

- 5/21/22 Incident of individual refusing to leave library property after a verbal warning that hazardous items in possession could not be brought on the property.* Exclusion notice issued for 30 days for harassing or threatening library staff or customers and personal property must fit under a chair and no hazardous materials.
- 5/24/22 Exclusion Notice issued for 90 days to Library User for possession of a weapon.
- 5/24/22 Incident of individual in a parked vehicle for an extended period entered the library with a knife and exited before police were called. Exclusion notice issued to individual for 90 days.
- 5/25/22 Incident of individual who became unruly and disruptive when the sound booth was occupied by another customer. Exclusion notice issued for 30 days for harassing or threatening library staff or customer, staring at, following or photographing library staff or customers., and disturbing others.
- 5/25/22 Incident reported of the elevator malfunctioning and the elevator was parked for service.

- 5/26/22 Incident of individual attempting to use a lighter for a substance in the public restroom, but the Security Guard escorted out of the library. Exclusion notice issued for 90 days.
- 5/27/22 Incident of individual trying to enter the library while smoking and carrying potential weapon. Entry was not allowed.
- 5/28/22 Incident of individual stumbling in the parking lot throwing trash and food. Urinated in the bushes on University Ave. *
- 5/28/22 Incident of individual bathing in the restroom. Exclusion notice issued for 30 days for using the restroom inappropriately, harassing or threatening library staff or customers, and for not wearing a shirt.
- 6/3/22 Incident reported of the window in the children's area cracked and shattered in the outside double pane frame.
- 6/3/22 Incident reported of hypodermic needle found in the 3rd floor men's restroom toilet.
- 6/4/22 Incident report of individual requesting medical assistance.*
- 6/5/22 Incident of individual causing a disruption by malicious intent with library property and offensive or hostile behavior.
- 6/7/22 Incident of individual leaning over the 4th floor balcony and entered non-public areas. Exclusion notice issued for 30 days.
- 6/8/22 Incident reported of an individual who got their hand stuck in the door of the public elevator. Ice pack was offered with no further medical assistance requested.
- 6/9/22 Incident reported of individual vandalizing another customers property. * Exclusion notice issued for 365 days.
- 6/9/22 Incident reported of two individuals playing on the spinning chairs causing the chairs to tip over.
- 6/10/22 Incident reported of individual using restrooms inappropriately and harassing or threatening library staff or customer. Exclusion issued for 30 days.
- 6/11/22 Incident reported of individual sleeping in an unlocked bike locker.
- 6/11/22 Incident of individual behaving in a threatening manner.* Exclusion notice issued for 180 days.
- 6/11/22 Incident of individual requesting medical assistance for a head injury received at White Park.*

- 6/16/22 Incident reported of individual causing a disturbance, yelling at customers and using emergency stairwell. Exclusion notice issued for 60 days.
- 6/18/22 Incident reported of individual harassing customers in the parking lot. Exclusion notice issued for 90 days.
- 6/18/22 Incident reported of individual for sleeping in the innovation center and restroom. Exclusion notice issued for 30 days.
- 6/18/22 Incident reported of individual who scraped their hand. No medical was requested.
- 6/21/22 Incident reported of individual previously excluded for 365 days from Arlington Library on February 18, 2022.
- 6/24/22 Incident reported of individual with dog was asked to leave because the dog was coughing and caused a disturbance to other customers.
- 6/25/22 Exclusion notice issued to two individuals for 30 days for harassing or threatening library staff or customers and loitering with a cart and animal at the library entrance.
- 6/25/22 Incident reported of individual causing a disturbance in the Arcade. Exclusion issued for 30 days.
- 7/2/22 Incident reported of individual sleeping in the library after several warnings. Exclusion notice issued for 30 days.

- 5/20/22 Incident reported of several individuals throwing items at a customer. Exclusion notice issued for 30 days to four individuals for harassing or threatening library staff or customer.
- 6/4/22 Incident reported of individual using the restroom inappropriately. Exclusion notice issued for 90 days.

- 3. **Fiscal Responsibility** The Library's financial resources are not used for the incident report.
- Innovation The Library in collaboration with partnerships with the Riverside Police Department and the City Attorney's Office to coordinate effective enforcement of major violations of the Riverside Municipal Code Section 9.75.
- 5. **Sustainability & Resiliency** The Library, City Attorney's Office and the Board of Library Trustees regularly review of the Rules of Library Conduct to ensure that the Rules of Library Conduct are current with local, state, and federal laws.
