2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
3 RIVERSIDE, CALIFORNIA, AMENDING RESOLUTION NO.
4 21052 AND THE MASTER FRINGE BENEFITS AND SALARY
5 PLAN TO APPROVE THE TITLE CHANGE OF THE EXISTING
6 BUILDING PERMIT TECHNICIAN CLASSIFICATION,
7 CREATION OF THE CLASSIFICATIONS AND SALARY
8 RANGES FOR THE SENIOR PERMIT TECHNICIAN AND THE
9 HVAC SUPERVISOR; UNIT DESIGNATION CHANGES FOR
10 THE CITY PLANNER AND THE ECONOMIC DEVELOPMENT
11 MANAGER CLASSIFICATIONS; AND DELETION OF THE
12 LEGAL SERVICES MANAGER CLASSIFICATION.

13 WHEREAS, on October 4, 2005, Resolution No. 21052 was adopted by the City Council
14 thereby adopting the Master Fringe Benefits and Salary Plan ("FBSP"); and

15 WHEREAS, the FBSP includes the fringe benefits and salary plans for City employees;
16 and

17 WHEREAS, the FBSP has been amended several times to update the benefits and
18 salaries; and

19 WHEREAS, the Job Code Table of the FBSP needs to be revised to reflect the title
20 change of the existing Building Permit Technician classification; and

21 WHEREAS, the Job Code Table of the FBSP needs to be revised to reflect the creation of
22 the classifications and salary ranges for the Senior Permit Technician and the HVAC Supervisor;
23 and

24 WHEREAS, the Job Code Table of the FBSP needs to be revised to reflect the unit
25 designation changes for the City Planner and the Economic Development Manager
26 classifications; and

27 WHEREAS, the Job Code Table of the FBSP needs to be revised to reflect the deletion of
28 the Legal Services Manager classification.

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, as
follows:

Section 1: Resolution No. 21052 and the Master Fringe Benefits and Salary Plan are
hereby amended to 1) approve the title change of the existing Building Permit Technician; 2)
approve the creation of the classifications and salary ranges for the Senior Permit Technician and

1 the HVAC Supervisor; 3) approve the unit designation changes for the City Planner and the
2 Economic Development Manager classifications; and 4) approve the deletion of the Legal
3 Services Manager classification; all as set forth in Exhibit “A” attached hereto and incorporated
4 herein by reference.

5 Section 2: Authorize the City Manager, or his designee, to make minor, non-
6 substantive changes to the Master Fringe Benefits and Salary Plan and any related policies,
7 procedures or documents necessary to implement these provisions.

8 Section 3: The provisions of this resolution shall be operative upon adoption.
