## BACKGROUND

1. Western Municipal Water District created and is leading the Solve the Water Crisis Coalition  
(As of mid-June, 21 other agencies have signed onto the Coalition)
2. As a result of the extreme weather events California has been experiencing coupled with the ongoing drought and dwindling water supplies in existing state storage facilities, action is needed now to secure California's water future.

## BACKGROUND

3. The mission of the "Solve the Water Crisis Coalition" is to educate and bring into sharp focus the ongoing water supply crisis that already impacts residents, quality of life, economic growth, community health, and the environment, as well as risking California's future.
4. Solve the Water Crisis Coalition will advocate for solutions to expand water storage and conveyance systems. Water conservation alone will not solve CA's water crisis.
5. Advocate Administration and Legislature prioritize funding for projects from existing state budget surplus to solve statewide water supply problems.

## DISCUSSION

Solve the Water Crisis will:

- a. Elevate water as a crisis that is already here and educate State leadership that this crisis must be solved to protect the State's future
- b. Prioritize California legislators, regulators, and Administration as the Coalition's key audience
- c. Demonstrate the need for comprehensive, long-term investments, improved science, and regulatory reforms to increase water supply for the State

## DISCUSSION

1. The Coalition will meet monthly to assess progress and discuss strategy
2. A Steering Committee made up of 7-10 GMs lead the Coalition
3. Each participating agency will contribute a payment of \$15,000 to cover the program
4. Western hired KP Public Affairs to manage the Coalition program
  - a. Developing material, messaging, media and website campaigns
  - b. Outreach and coalition building
  - c. Completing research, tracking, and measuring the effects of the coalition
5. By the end of September 2022, KP Public Affairs will create a report summarizing the effectiveness of the Coalition and providing recommendations.

Depending on the success of this effort, a second phase may be implemented at which time a second round of funding may be requested

2. Designate Public Utilities General Manager as the designee and Assistant General Manager as the alternate designee to represent the City of Riverside in the Solve the Water Crisis Coalition.
