RECOMMENDATION

This is a discussion item on City Council policies related to filling of board member partial term vacancies.

No staff Recommendation.

BACKGROUND/DISCUSSION

At the July 20, 2022 Cultural Heritage Board (CHB) meeting, Board Member Tobin requested that an item be added to the next available agenda to discuss the current City Council policy on filling partial term vacancies for Board Members.

Resolution No. 23618 (Exhibit 1) was adopted by City Council on September 2, 2020, and established rules of procedure and order of business for the City Council of the City of Riverside and related functions and activities. Article XIV (BOARDS, COMMISSIONS, AND COMMITTEES) outlines the procedures for filling vacancies and policies related to attendance and partial terms. Per item H of Article XIV, "A partial term of more than one year shall be considered a full term. Residents appointed mid-year to boards and commissions shall serve full terms of up to and not-to-exceed four year, expiring on March 1st of the corresponding year."

The boards and commissions terms are established in Article VIII, Section 802 of the City Charter. Per Section 802, "The members thereof shall serve for a term of four years and until their respective successors are appointed and qualified and may serve for not more than two consecutive full terms."

STRATEGIC PLAN

community members to improve transparency, build public trust, and encourage shared decision-making).
