This THIRD AMENDMENT TO AGREEMENT FOR MUNICIPAL TREE MAINTENANCE SERVICES IN CITY PARK SITES FOR CITY OF RIVERSIDE ("Third Amendment") is made and entered into this _____ day of _____, 2022, by and between the CITY OF RIVERSIDE, a California charter city and municipal corporation ("City"), and WEST COAST ARBORISTS, INC., a California corporation located at 2200 East Via Burton Street, Anaheim, CA 92806, State Contractor's License No. 366764 ("Contractor"), as follows:

RECITALS

WHEREAS, on January 1, 2019, City and Contractor entered into that certain Agreement for Municipal Tree Maintenance Services in City Park Sites for City of Riverside ("Agreement"); and

WHEREAS, on July 1, 2021, City and Contractor entered into that certain First Amendment to Agreement for Municipal Tree Maintenance Services in City Park Sites for City of Riverside ("First Amendment"); and

WHEREAS, on June 1, 2022, City and Contractor entered into that certain Second Amendment to Agreement for Municipal Tree Maintenance Services in City Park Sites for City of Riverside ("Second Amendment"); and

WHEREAS, the Agreement is set to expire June 30, 2022; and

WHEREAS, City and Contractor would like to extend the term of the Agreement for one (1) additional year, to June 30, 2023; and

WHEREAS, City and Contractor would like to increase the compensation during the Extended Term of the Agreement in the amount of Four Hundred Sixty-Two Thousand Two Hundred Forty Dollars (\$462,240.00), plus an additional ten percent (10%) change order authority in the amount of Forty-Six Thousand Two Hundred Twenty-Four Dollars (\$46,224.00), for a combined total compensation not to exceed Five Hundred Eight Thousand Four Hundred Sixty-Four Dollars (\$508,464.00).

NOW, THEREFORE, in consideration of the foregoing recitals which are incorporated herein by this reference, City and Contractor agree as follows:

1. Section 2, Term, of the Agreement, is hereby extended for one (1) additional year, to June 30, 2023.

2. City shall pay Contractor during the Extended Term of the Agreement the amount of Four Hundred Sixty-Two Thousand Two Hundred Forty Dollars (\$462,240.00), plus an additional ten percent (10%) change order authority in the amount of Forty-Six Thousand Two Hundred Twenty-Four Dollars (\$46,224.00), for a combined total compensation not to exceed Five Hundred Eight Thousand Four Hundred Sixty-Four Dollars (\$508,464.00).

3. All terms and conditions of the Agreement not inconsistent with this Third Amendment shall remain in full force and effect and are incorporated herein by this reference as though set forth in full.






