STATE LIBRARY AND SOUTHERN CALIFORNIA LIBRARY COOPERATIVE HOME CONNECTIVITY KIT PROJECT REIMBURSEMENT GRANT - TECHNOLOGICAL ITEMS - SUPPLEMENTAL APPROPRIATION

The City Council (1) accepted a reimbursement grant award from the California State Library and Southern California Library Cooperative Home Connectivity Kit Project in the amount of \$25,000 for the library to purchase technological items; (2) with at least five affirmative votes, upon receipt of the reimbursement grant award, authorized the Chief Financial Officer, or designee, to record an increase in estimated revenues and supplemental appropriation in the amount of the grant award in the Grants and Restricted Programs Fund, Library Gift & Trust revenue and expenditure accounts; and (3) authorized the City Manager, or designee, to execute grant documents with the California State Library, including making minor and non-substantive changes.

DONATIONS FOR PARKS, RECREATION AND COMMUNITY SERVICES DEPARTMENT EVENTS AND PROGRAMS - SUPPLEMENTAL APPROPRIATION - FUNDS TRANSFER

The City Council (1) accepted monetary donations in the amount of \$66,552.67 received by Parks, Recreation and Community Services Department; (2) with at least five affirmative votes, authorized the Chief Financial Officer, or designee, to record supplemental appropriations in the Grants and Restricted Programs Fund totaling \$66,552.67, comprised of the following programs within the Grants and Restricted Programs Fund: \$15,050.75 for Aquatics, \$18,661.92 for Special Events, \$32,000 for the Riverside Arts Academy, and \$840 for Senior Programming.

PURCHASE - BALLISTIC VESTS - SPECIAL WEAPONS AND TACTICS TEAM

BULLETPROOF VEST PARTNERSHIP PROGRAM - SUPPLEMENTAL APPROPRIATION

The City Council (1) approved the acceptance of grant funding in the amount of \$29,732.28 from the 2021 Patrick Leahy Bulletproof Vest Partnership Program from the Bureau of Justice Assistance for the period of April 1, 2021 through August 31, 2023; (2) with at least five affirmative votes, and upon receipt of the grant award, authorized the Chief Financial Officer, or designee, to record an increase in estimated revenues and appropriate expenditures in the amount of the grant award in the Grants and Restricted Programs Fund, for the Bureau of Justice Assistance, Bulletproof Vest Partnership Program; and (3) authorized the City Manager, or designee, to execute all necessary grant documents for the Bureau of Justice Assistance, 2021 Patrick Leahy Bulletproof Vest Partnership Program, including making minor and non-substantive changes.

POLICE DEPARTMENT AUTHORIZED AMMUNITION


The City Council approved a purchase order with Dooley Enterprise, Inc., Anaheim, for the purchase of various types of duty and training Police Department authorized ammunition for Department issued handguns and patrol rifles in the amount of \$185,537.30 for Fiscal Year 2022-23.

SOLVE THE WATER CRISIS COALITION

The City Council (1) approved an annual expenditure of \$15,000 for participation in Solve the Water Crisis Coalition for Fiscal Years 2022-23 and 2023-24, at the discretion of the Utilities General Manager, for a total expenditure not to exceed \$30,000, subject to the availability of budgeted funds; and (2) designated the Public Utilities General Manager as the designee and Assistant General Manager as the alternate designee to represent the City of Riverside in the Solve the Water Crisis Coalition.

AGREEMENT AMENDMENT - BIOSOLIDS HAULING AND DISPOSAL/REUSE SERVICES

The City Council (1) approved the Second Amendment to the Agreement with Denali Water Solutions, LLC, Garden Grove, for Biosolids Hauling and Disposal and Reuse Services to extend the contract term through December 31, 2022, and increase the compensation during the extended term by an additional amount of \$800,000, for a new contract amount of \$16,186,211; and (2) authorized the City Manager, or designee, to

SPEED LIMIT ZONE - JURUPA/RUTLAND/CREST - MOBLEY/HOLE/COOK - ORDINANCE INTRODUCED

The City Council introduced an ordinance to establish a (1) 35 mile-per-hour speed limit zone on Jurupa Avenue from Rutland Avenue to Crest Avenue; and (2) 30 mile-per-hour speed limit zone on Mobley Avenue from Hole Avenue to Cook Avenue; whereupon an Ordinance entitled "An Ordinance of the City of Riverside, California Amending Section 10.76.010 of the Riverside Municipal Code Designating the Prima Facie Speed Limits for Streets and Portions Thereof in Accordance with the Provisions of Sections 10.20.020 and 10.20.030", was presented and introduced.

BID 7837 - MARTIN LUTHER KING BOULEVARD AND ALTA MESA DRIVE SEWER IMPROVEMENTS PROJECT - MARTIN LUTHER KING/ALTA MESA

The City Council approved an increase in change order authority for Bid 7837 regarding the Martin Luther King Boulevard and Alta Mesa Drive Sewer Improvements Project to G. Hurtado Construction, Inc., from \$150,000 to \$393,835 (25 percent) for a total contract amount of \$1,969,177.

REQUEST FOR PROPOSAL 2176 - AGREEMENT - BACKFLOW TESTING, REPAIR, AND REPLACEMENT SERVICES
