## BACKGROUND

1. **July 2020 – February 2021:** Discussions on potential surplus properties for disposition
2. **May 2021:** City Council directed staff to complete a community engagement process for the future use of the Fairmount Golf Course property and return to the BEC for a recommendation to City Council
3. **August 2021:** Staff released RFP No. 2119 seeking a firm to conduct a community engagement program, including a design charette, for the Property and selected candidate KTUA of San Diego

## BACKGROUND

4. **April 2022**: The Economic Development, Placemaking and Branding/ Marketing Committee directed staff to negotiate PSA with KTUA
5. **May 2022**: Economic Development, Placemaking and Branding/ Marketing Committee requested staff return with an update on the community engagement program, including a design charette, before moving forward with the Professional Consultant Services Agreement with KTUA

## DISCUSSION

1. Multi-day design charette
  - a) Invite community stakeholders to engage in an inclusive visioning process
  - b) Future of Fairmount Golf Course
2. Community concerns led to additional research of the property and discovery of a 1992 Federal Land and Water Conservation Grant
3. California State Parks Department - May 2022 confirmed specific use restrictions, which were not reflected on the City's property deeds



## DISCUSSION: FEDERAL LAND AND WATER CONSERVATION GRANT

### SECTION 6(f)(3) of Public Law 88-578:

1. Must remain public outdoor recreation
2. Term: in perpetuity
3. More research needed on what improvements may qualify



## DISCUSSION: FEDERAL LAND AND WATER CONSERVATION GRANT

### Property Conversion Requires:

1. Approval of the National Secretary of the Interior
2. Substitution of other recreation property at equal fair market value, equivalent usefulness, and location
3. Additional requirements may apply

1. Santa Ana Working Group
  - a) Opportunities for development along the Santa Ana River
  - b) Considered strategies for implementation
  - c) Public/private Investment
  - d) Improve public awareness.
  
2. February 2022 - City Council direction
