- SUBJECT: UPDATE ON THE 2022 FOURTH OF JULY FIREWORK SHOWS AND CELEBRATION, AND PROVIDE INPUT ON THE SECOND LOCATION OR AERIAL DISPLAY OPTIONS FOR THE 2023 AND 2024 FIREWORK SHOW

ISSUE:

Review the 2022 Fourth of July firework shows and celebration and provide input on the second location or aerial display options for the 2023 and 2024 firework show.

RECOMMENDATION:

That the Safety, Wellness and Youth Committee:

- 1. Receive an update on the July 4, 2022, firework shows and celebration;
- 2. Discuss the possibility of hosting the Fourth of July shows on the Saturday prior as neighboring cities have shown an increase in attendance and a major cost savings by not hosting the event on a holiday;
- 3. Provide input on moving forward with a Sole Source Services Agreement to secure a qualified pyro tech vendor for a term covering April 1, 2023, through July 5, 2024;
- 4. Provide input on the second location for the 2023 and 2024 firework show; the first show will continue at La Sierra Park.

BACKGROUND:

Since 1996, the firework shows have been a staple of Riverside's Fourth of July celebration, with shows at both La Sierra Park and on the top of Mt. Rubidoux. Over the years, the firework shows have drawn more than 100,000 families each year from all over the Inland Empire.

On February 15, 2022, City Council approved a Sole Source Services Agreement with Pyro Spectaculars, Inc. to provide two firework shows at La Sierra for a term of covering April 1, 2022, through July 5, 2024, and at Ryan Bonaminio Park for a term covering April 1, 2022, through July 5, 2022.

On July 4, 2022, the Parks, Recreation and Community Services Department (PRCSD) hosted two firework shows at La Sierra Park and Ryan Bonaminio Park. In addition to the firework shows, residents enjoyed a car show, concert, and food vendors at La Sierra Park, and a DJ at Ryan Bonaminio Park.

DISCUSSION:

Pyro Spectaculars will continue to provide a firework show at La Sierra Park, per the Service Agreement's term of April 1, 2022 – July 5, 2024. The additional enhancements that were provided (concert/car show) are not included in the department budget, therefore, private donations/sponsors will be sought after. The La Sierra Advisory Board will be looking to offset the cost by seeking sponsorship to continue hosting the additional activities.

The firework shows include multiple departments combining their efforts to deliver successful shows. The event requires substantial investment and commitment of staff and financial resources, from Fire, Police, PRCSD, Traffic Engineering, Public Works, Arts and Cultural Affairs, and Code Enforcement.

In response to City Council's recommendations to find alternative sites to host a firework show, PRCSD staff continue to work closely with the Riverside Fire Department to evaluate locations. Location considerations include fall out zone, traffic plan, security, maintenance, visibility, cost, and access. The current list includes:

POTENTIAL SECOND LOCATION FOR 2023 - 2024

Location 1: Mt. Rubidoux Location 2: Ryan Bonaminio Park Location 3: Ab Brown Sports Complex Location 4: UCR Sports Complex

Staff researched alternative aerial options such as drone and laser light shows and skywriters, however, the cost is high, and the visual effects are minimal compared to a traditional firework show. Due to the expensive nature and minimal impact, staff do not recommend the alternative options.

Additional locations that staff researched included the Riverside Airport, City Hall, and the Main Library. These locations are not feasible due to the fallout zone and increased safety concerns.

To secure a vendor, staff will work with the Purchasing Division on a Sole Source Agreement. This process may take up to three months.

Due to the lack of service vendors within the State of California, it is recommended to have a Sole Source Agreement with the current vendor.

STRATEGIC PLAN ALIGNMENT:

The Fourth of July Show contributes to **Strategic Priority 1 – Arts, Culture and Recreation**, and specifically **Goal 1.2**, to enhance equitable access to arts, culture, and recreational services offerings.

This action aligns with each of the Cross-Cutting Threads as follows:

- 1. **Community Trust** Providing a controlled Fourth of July show at a City facility increases community trust and benefits the city's diverse populations.
- 2. **Equity** Providing two shows in two different locations allows a larger segment of the community to view the Fourth of July Show.
- 3. **Fiscal Responsibility** Securing a reliable vendor ensures that financial resources are being used for quality services provided to the public.
- 4. **Innovation** The proposed location of the Fourth of July firework shows prepares for the future through collaborative partnerships and an adaptive process.
- 5. **Sustainability & Resiliency** The Fourth of July firework shows are the highest attended PRCSD events. Providing various options allows the City of Riverside to continue to provide in demand events to residents for future years.

FISCAL IMPACT:

The total fiscal impact is subject to change and are contingent on the options selected. The figures below are preliminary estimates and are not final. The Department has \$45,000 budgeted for a second fireworks show and will require a supplemental appropriation for any selection above the budgeted amount.
