Such written determination shall include a description of the consultant's duties and, based upon that description, a statement of the extent of disclosure requirements. The department head's determination is a public record and shall be retained for public
28 inspection in the same manner and location as this conflict of interest code.

8 **Broad Disclosure**

9 1. Must report investments, business positions, and income from sources located in, planning to
do business in, or doing business in the City of Riverside; and

10 Interests in real property located in the City of Riverside and also within a two mile radius of any
property owned or used by the City of Riverside which is not within the City limits.

11 **Real Property Disclosure**

12 2. Must report interests in real property located in the City of Riverside and also within a two
mile radius of any property owned or used by the City of Riverside which is not within the City
limits.

13 **Financial Interest Disclosure**

14 3. Must report investments, business positions, and income from sources located in, planning to
do business in, or doing business in the City of Riverside.

15 **Disclosure Based on Department**

16 4. Must report investments, business positions, and income from business entities located in,
planning to do business in, or doing business with the City of Riverside subject to the following: no
17 financial interest need be reported unless it is in or from a source which provides services, supplies,
material, machinery or equipment of the type utilized by or which is subject to the regulatory permit
18 or licensing authority of the department which filer is employed.

19 **Disclosure Based on Position**

20 5. Must report investments, business positions, and income from business entities located in,
planning to do business in, or doing business with the City of Riverside subject to the following: no
21 financial interest need be reported unless it is in or from a source which provides services, supplies,
material, machinery or equipment of the type utilized by or which is subject to the regulatory permit
22 or licensing authority of the position which the filer currently fills.

23 **Consultant Disclosure**

24 6. Must report investments, business positions, and income from business entities located in,
planning to do business in, or doing business with the City of Riverside subject to the following: no
25 financial interest need be reported unless it is in or from a source which provides services, supplies,
material, machinery or equipment of the type utilized by or which is subject to the regulatory permit
or licensing authority of the department by which the consultant is employed.

26 **Disclosure Based on Board and Commission Membership**

27 7. Must report investments, business positions, and income from business entities located in,
planning to do business in, or doing business with the City of Riverside subject to the following: no

1 financial interest need be reported unless it is in or from a source which provides services, supplies,
2 material, machinery or equipment of the type utilized by or which is subject to the regulatory permit
3 or licensing authority of the department with which filer's board or commission is associated.

4 **No Disclosure**

5 8. Need not file Statement of Economic Interest as members are not deemed to be designated
6 positions.

7 **State Filers**

8 9. Need not file an additional Statement of Economic Interests under this code as their filing
9 with the Fair Political Practices Commission fulfills reporting requirements. They are included in
10 this code only for disqualification purposes.
