# History

The Arlington Business Improvement District is an advisory board to the City of Riverside dedicated to promoting and enhancing the vitality of Arlington's BID Businesses. Established in October 2002 by a group of Arlington Businesses and Community Leaders, the BID has developed programs & partnerships to help fund beautification projects, sponsor special events, foster new business & local community relationships and promotion of business activities.





## Mission & Goals

The Arlington Business Partnership was organized for the following specific purposes:

- (i) to promote the commercial welfare of all businesses within the ABID;
- (ii) to promote both tangible improvements and promotional activities;
- (iii) to promote and fulfill a vision of prosperity for the area; and
- (iv) to promote enthusiasm, innovation and a sense of partnership among all businesses in the area and with all organizations sharing the same goal.



## Arlington BID Benefits



The ABP Vision is committing to the branding of Arlington as an attractive place to visit, work and do business; ABP operates the following programs focusing on the physical improvement and branding of the Arlington Business Improvement District.

## Beautification

### Physical Improvement Program Grants

- Matching Funds are provided up to \$1,000 for eligible improvements included but not limited to: exterior painting, new signage, exterior security cameras, parking lot resurfacing and lighting.

### Vandalism Repair Grants - Matching

Funds are provided up to \$1,000 for eligible repairs such as: window replacement.

## Arlington BID - Emerging Needs

The ABP has collected feedback from its Board of Directors, BID Businesses and Community Partners to identify the following universal needs we believe will benefit most if not all of the BID Businesses.

### Cleanliness & Safety

The Arlington BID would benefit from a revival of ABP's Clean & Safe Program introduced in 2017.

Should funding be available the ABP would reintroduce Clean & Safe with Quarterly BID trash pickups, sidewalk pressure washing, graffiti removal along with daily & active security monitoring as the "eyes & ears" of ABP & the City of Riverside.

ABP is proposing a change to the BID Tax Assessment to help fund this program.



## Arlington BID - Current Tax Assessment

The method and basis for levying the assessment in sufficient detail to allow each business owner to estimate the amount of the assessment to be levied against his or her business for the year.

### Current BID Tax Assessment

90% of a business owner's current business tax, with a \$400 maximum cap be applied within the existing boundaries of the Arlington BID. The method for levying this 90% tax assessment is to take the base business tax levied by the City of Riverside and increase it by 90%.

### **EXAMPLE BUSINESS TAX PAYMENT – 90% ASSESSMENT WITH \$400 MAXIMUM CAP**

**Base Business Tax + Arlington BID Assessment Fee(Base multiplied by 0.90) = Total Business Tax Due**

**Example #1 \$100.00 + \$90.00 = \$190**

**Example #2 \$1,000.00 + ~~\$900.00~~ (\$400) = ~~\$1,900~~ (\$1,400)**



# Arlington BID - Proposed Tax Assessment

100% of a business owner's current business tax, with no cap applied within the existing boundaries of the Arlington BID. The method for levying this 100% tax assessment is to take the base business tax levied by the City of Riverside and increase it by 100%.

## **EXAMPLE BUSINESS TAX PAYMENT – 100% ASSESSMENT WITH NO CAP**

**Base Business Tax + Arlington BID Assessment Fee(Base Tax) = Total Business Tax Due**

**Example #1 \$100.00 + \$100.00 = \$200**

**Example #2 \$1,000.00 + \$1,000.00 = \$2,000**

Based on 2020/2021 Business Tax Assessments:

~72% of Businesses in the BID would face an annual increase up to \$45 as they are currently under the \$400 Maximum Cap and the increase can be calculated.

~28% of Businesses in the BID currently hit the \$400 cap rate and the direct impact is unable to be calculated because ABP isn't aware of the individual base tax assessment for these businesses.




Hole Ave from Tyler St to Magnolia Ave

Tyler St - From 3801 - 4099 to 3380 - 4140 including Galleria at Tyler

Magnolia Ave - From 9001 - 10299 to 8945 - 11194

Indiana Ave - From 9390 - 9958 to 9390 - 10406

La Sierra Ave - 3653 - 4350 (Both sides) & 4351 - 4845 (Odd side Only)

Polk St - 3500 - 4088

Sherman Dr - 3800 - 3900

Rudicill St - From 9500 - 9599 to 9500 - 9699
