- (1) Purchase approval of 45 ballistic vest from TYR Tactical in the amount of \$131,025.95. The purchase will be made from the State COPS Grant Account for Special Weapons and Tactics Team.
- (2) Approval of a purchase agreement with SC Commercial, LLC to provide Motor Fuels and Lubricants for City Police Vehicles with four additional one-year renewal options in the amounts of \$484,000 for FY 23/24, \$532,400 for FY 24/25, \$585,640 for FY 25/26, and \$644,204 for FY 26/27.
- (3) Grant Award acceptance from the Bureau of Justice 2022 Patrick Leahy Bulletproof Vest Partnership Program in the amount of \$29,732.28 to offset the cost of police bulletproof vests from April 1, 2021 through August 31, 2023.
- (4) Purchase order approval with Dooley Enterprises, Inc. in the amount of \$185,537.30 for the purchase of various types of duty and training ammunition.

### QUARTERLY REPORT

During the period of April through June 2022, the CPRC Office received 22 phone calls and one letter. Of those contacts, eleven were related to Riverside Police department and four other law enforcement agencies. Disposition of those contacts resulted in one citizen complaint submission.
