FISCAL YEAR 2022-23 WATER CONSERVATION SURCHARGE PROGRAM - RESIDENTIAL AND COMMERCIAL TURF REMOVAL - CONTINUED FROM SEPTEMBER 6, 2022

Following discussion, it was moved by Councilmember Perry and seconded by Councilmember Edwards to approve the (1) change to the Residential Turf Removal Program, to increase funding from \$3 per square foot of turf to \$5 per square foot of turf, estimated total fiscal impact for Fiscal Year 2022-23 of \$125,000; (2) change to the Commercial Turf Removal Program, to increase funding from \$3 per square foot of turf to \$5 per square foot of turf, estimated fiscal impact for Fiscal Year 2022-23 of \$150,000; (3) new Residential Flow Monitoring Device Program, estimated fiscal impact for Fiscal Year 2022-23 of \$25,000; (4) new Residential Hose Bib Program, estimated fiscal impact for Fiscal Year 2022-23 of \$10,000; and (5) purchase of soaker hoses for the Tree Care Program, estimated fiscal impact for Fiscal Year 2022-23 of \$10,000.
