RECITALS

WHEREAS, on July 30, 2019, the City and Consultant entered into a Master Professional Consultant Services Agreement for Various Engineering Services for Public Utilities Department, Electric Division, Non-G.O. 165 Projects ("Master Agreement"); and

WHEREAS, the City and Consultant have not entered into any Supplemental Agreements for Assigned Project for Various Engineering Services for Public Utilities Department, Electric Division, Non-G.O. 165 Projects ("Supplemental Agreement"); and

WHEREAS, the City desires to have Consultant continue providing the services referenced in that Master Agreement; and

WHEREAS, the City and Consultant desire to amend the Master Agreement to extend the term of the Agreement for one additional year, to end June 30, 2023.

NOW, THEREFORE, in consideration of the foregoing recitals, which are incorporated herein to the Master Agreement, the parties hereto mutually agree to the following amendment to the Agreement:

- 1. Section 3, "Term," is hereby amended to extend the term of the Agreement for one additional year, to end June 30, 2023, or the required date for completion of an assigned project, provided such project was assigned prior to June 30, 2023.
- 2. All other terms and conditions of the Master Agreement between the parties which are not inconsistent with the terms of this First Amendment shall remain in full force and effect as if fully set forth herein.
