5. Nancy Taylor – Opposed. Wants to keep the area an environmental and wild land area, does not feel we need any more projects including a skatepark.
6. Ruben Equihua – Support. Would like to see better made and bigger skate parks in the City of Riverside. Possibly somewhere that does not disturb the community members.
7. Andre Padilla Montague – Support. Wanted to express how important a new skatepark would be because of the passion their community has for the sport and keep kids in safe zones and off the streets.
8. Jeremiah Thompson/Andrew Manriquez – Supports. Having a skateboard park would keep kids off the streets and skating or riding bikes where not allowed would stop. Skateboarding is great way to exercise and good for mental health.

9. Colin McGuire – Support. Feels like Riverside is overdue for a new skateboard park. Pointed out that in 2020 Skateboarding was introduced to the Olympics. Feels the City of Riverside would have the potential to produce future Olympians if a new and bigger skate park was built.
10. Sidney Robinson – Support. It is important to support this project. This sport is diverse and a good escape and outlet. Riverside is special and would like to see the progress to go forward.
