A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE. CALIFORNIA, **CONFIRMING** THE ANNUAL **REPORT** OF ARLINGTON BUSINESS PARTNERSHIP, ACTING IN ITS CAPACITY AS **ADVISORY BOARD** TO THE ARLINGTON **BUSINESS** IMPROVEMENT DISTRICT, LEVYING ASSESSMENTS FOR FISCAL YEAR 2022-2023 WITH THE AMENDED BOUNDARIES AND LEVY AMOUNTS.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, California, pursuant to Section 36535 of the Streets & Highways Code, as follows:

- 1. The 2022-2023 annual report of the Arlington Business Partnership, acting in its capacity as the advisory board to the Arlington Business Improvement District, is confirmed.
- 2. The boundaries of the Arlington Business Improvement District have been modified as outlined in the 2022-2023 annual report of the Arlington Business Partnership.
- 3. The levy for the Arlington Business Improvement District is imposed for the fiscal year 2022-2023, on each business within the Arlington Business Improvement District beginning 30 days from the date of adoption stated below, at the rate of 100% of the non discounted City of Riverside business tax charge.
