




Overall Sentiment



We have 2 Community Centers- (Villegas Community and The Home of Neighborty Service) however, our centers are the least funded by Federal, State, City and Regional funding- but, both serve our Community Daily- Can we have someone who will advocate for us more Fiercely? Our Community Daily- Can we have someone who will advocate for us more Fiercely? Our Community is mostly blue collar, with a large Senior population, the rest are mixed families, but, even with our tax dollars, we have gaps of access to required services. In my review of the proposed community engagement plan, several issues were apparent. Very obvious is the lack of equal number of meetings in all the wards. Wards 2 and Ward 3 each need another planned meeting scheduled. Then, the time between meetings in each ward varies greatly. Quote: The proposed Plan will be a coordinated effort led by Riverside City staff in partnership with local community stakeholders that will consist of three phases of outreach: To move from education to motivation will take time between meetings to allow enough time to Fill-in-Gaps in each ward and develop Communities of Interest, like in Ward 4 it's only 9 days between meeting. The Outreach Plan covers translations but does not consider the lives of our "bedroom" city. Real equulty would be achieved if meetings occurred when commuters can attend in the evening or weekends. I have recommendations regarding the type of redistricting commission, type of process and what should be the top redistricting criteria.

In the list below of the Riverside City Redistricting Staff report, where they reference 2012 redistricting criteria, it doesn't prioritize the Voting Rights Act.

- 1. Equalize the population count in each Ward within 10% (top to bottom)
- 2. Achieve +5% from optimal population per Ward
- 3. Comply with all applicable laws
- 4. Avoid disqualification of City Councilmembers during a term
- 5. Maintain continuity of existing Wards, to the extent possible
- 6. Draw Wards that are compact and contiguous
- 7. Use natural, geographic boundaries to the extent possible
- 8. Maintain cohesive neighborhoods and community interests, to the extent possible
- 9. Consider school districts and avoid dividing same, to the extent possible
- 10. Maintain income diversity within Wards, to the extent possible

The Fair and Inclusive Redistricting for Municipalities and Political Subdivisions Act (FAIR MAPS Act), requires the city to comply with the federal Voting Rights Act of 1965 (VRA), and, to the extent practicable, keep communities of interest together. The FAIR MAPS Act also requires cities to include with each draft map "information on the total population, citizenship voting age population, and racial and ethnic characteristics of the citizenship voting age population of each proposed supervisorial district. If city maps only include total population data and fail to disclose CVAP data for any of the proposed districts, then the city fails to comply and can risk litigation. Without the CVAP data, broken down by racial and ethnic demographics, the public cannot evaluate whether the proposed maps comply with Section 2 of the VRA. Further, federal law is clear that in

determining compliance under Section 2 of the VRA, "CVAP is the appropriate measure to use in determining whether an additional effective majority-minority district can be created." (Luna v. County of Kern). The new Riverside City redistricting maps should not only contain total Census 2020 population data, population percentages and CVAP data included.

According to Census 2020, in the City of Riverside there are 314, 998 people who live in the City of Riverside. There are 53.7 % of Hispanic/Latino, 6.2% African Americans, and 7% are Asian American Pacific Islanders. Out of the Citizen voting age population, there are 241, 620 people, which are 50.60% Hispanic/Latino, 6.32% African American and 7.99% are African American. We should have at least three to four Latino Majority Wards out of the seven Riverside wards. We would like Racially polarized Voting Analysis to be taken into consideration when redrawing the ward lines. Voting Rights Act (VRA) to provide a statutory remedy for racial vote dilution. At the heart of vote dilution law is the concept of racially polarized voting. Voting is polarized when (1) the political prefer- ences of majority-race and minority-race voters diverge substantially and the racial majority votes with enough cohesion to usually defeat the minority's candidates of choice. We call these the "preference polarization" and "voting power" requirements. Since the Supreme Court's 1986 decision in Thornburg v Gingles, plaintiffs have had to satisfy both conditions and propose a remedial district at the outset of their case. Only if this threshold Gingles showing has been made does the court apply the liability standard prescribed by statute: whether the "totality of circumstances" indicates that plaintiff-race voters "have less opportunity than other members of the electorate to participate in the political process and to elect representatives of their choice."

As for the type of Riverside city redistricting commission, we as Brown and Black Redistricting Alliance recommend that both Independent and Hybrid Commission is the way to have an independent, community driven process for redistricting.

- The Independent Commission conducts all the public hearings and makes the final decision on the map. The City Council has no approval authority.
- Hybrid Commission conducts some of the public hearings and makes recommendations on one to two maps. The City Council can only adopt one of the recommended maps.
