proposed by the Arlington Business Partnership, adopt a Resolution confirming the annual report of the Arlington Business Partnership, acting as the Advisory Board to the Arlington Business Improvement District, and levying assessments for Fiscal Year 2022-2023, and if approving boundary and assessment modifications, adopt an Ordinance to amend Chapter 3.48 of the Riverside Municipal Code. Two people spoke on the matter. The public hearing was officially closed.

Following discussion, it was moved by Councilmember Perry and seconded by Councilwoman Plascencia to reject the recommendation of the Advisory Board to amend the boundaries of the Arlington Business Improvement District and to amend (increase) the assessment amount and only adopt a Resolution confirming the annual report of the Arlington Business Partnership, acting as the Advisory Board to the Arlington Business Improvement District, and levying assessments for Fiscal Year 2022-2023 in the same method and within the same boundaries as Fiscal Year 2021-2022, with no adoption of the Ordinance. The motion carried unanimously.

Whereupon, the title having been read and further reading waived, Resolution No. 23907 of the City Council of the City of Riverside, California, Confirming the Annual Report of The Arlington Business Partnership, Acting in its Capacity as the Advisory Board to the Arlington Business Improvement District, Levying Assessments for Fiscal Year 2022-2023, was presented and adopted.

CASE PR-2022-001391 - ZONING CODE TEXT AMENDMENT TO TITLE 19 - ZONING - DENSITY **BONUS - ORDINANCE INTRODUCED**

Hearing was called to consider Planning Case PR-2022-001391 (Zoning Text Amendment) for proposed Zoning Text Amendments to Title 19 (Zoning) of the Riverside Municipal Code related to repealing and replacing Chapter 19.545 (Density Bonus) and Zoning Cleanup items related to setbacks in the Industrial Zones, site location criteria for on-sale of alcoholic beverages, parking requirements for certain uses, required findings for Fair Housing Requests for Reasonable Accommodation, and modifications to definitions. No one spoke on the matter. The public hearing was officially closed.

Following discussion, it was moved by Councilmember Edwards and seconded by Councilwoman Plascencia to (1) determine that Planning Case PR-2022-001391 is exempt from further California Environmental Quality Act (CEQA) review pursuant to Section

15061(b)(3) (General Rule), as it can be seen with certainty that approval of the project will not have an effect on the environment; (2) approve Planning Case PR-2022-001391 (Zoning Text Amendment) based on the findings summarized in the staff report; and (3) introduce an Ordinance amending Title 19 (Zoning) of the Riverside Municipal Code. The motion carried unanimously.

Whereupon, an Ordinance entitled "An Ordinance of the City Council of the City of, Amending Various Sections in Title 19 of the Riverside Municipal Code," was presented and introduced.

Councilwoman Plascencia reported on Raincross Group event acknowledging State legislators, Love Riverside event, 2nd Annual League of United Latin American Citizens (LULAC) scholarship lunch, office hours, and youth office hours. Councilmember Perry reported on Love Riverside Serve Day, home plates stolen from the park, and welcomed the Grier Leadership Academy students. Councilmember Hemenway reported on National Manufacturing Day. Mayor Lock Dawson reported on Night of Art and Innovation, Beautify Riverside, Downtown Cleanup and thanked the City Clerk for Redistricting efforts.

CONSENT CALENDAR

It was moved by Councilmember Hemenway and seconded by Councilmember Perry to approve the Consent Calendar as presented affirming the actions appropriate to each item except the Agreement with the DÉCOR IQ of San Antonio, Texas, to design, install, and maintain custom decorations for 2022 Festival of Lights removed from the Consent Calendar for separate discussion. The motion carried unanimously.

BOARD AND COMMISSION APPOINTMENT AND RESIGNATIONS

The Mayor and City Council (1) appointed Andrew-Bryce Hudson to the Ward 4 seat on the Cultural Heritage Board for a term through March 1, 2026; (2) accepted the resignation of Nathan Iverson from the Park and Recreation Commission Ward 5 seat; and (3) accepted the resignation of Giovanny Palacios from the Human Resources Board Ward 5 seat, effective immediately.

AGREEMENT - OPEN SYSTEM INTERNATIONAL BASED ELECTRIC SUPERVISORY CONTROL AND DATA ACQUISITION (SCADA) SYSTEM AND ENERGY MANAGEMENT SYSTEMS UPGRADE

The City Council approved the Land Use, Sustainability, and Resilience Committee recommendation to (1) approve the Professional Consultant Services Agreement for the upgrade of existing Open System International Based Electric Supervisory Control and Data Acquisition System and Energy Management Systems with Open Systems International, Inc., Medina, Minneapolis, for a five-year term through November 30, 2027, in the amount of \$2,121,116, with an additional \$45,000 for tangible taxable items; and (2) authorized the City Manager, or designee, to execute the Agreement, including making minor, non-substantive changes, and to sign all documents and instruments necessary to complete the transactions.

AGREEMENT - POTABLE WATER WELL AND TEMPORARY CONSTRUCTION EASEMENT - WATERMAN/DUMAS IN SAN BERNARDINO

The City Council (1) approved the Agreement with QR Waterman DC, LLC, for a potable water well and a temporary construction easement for future construction of a new property located at the southwesterly corner of Waterman Avenue and Dumas Street in the City of San Bernardino; and (2) authorized the City Manager, or his designee, to execute the Agreement with QR Waterman DC, LLC, including making minor and non-substantive changes and signing all documents and instruments necessary to complete the transaction.

DEPARTMENT OF AGRICULTURE-SUPPLEMENTAL NUTRITION ASSISTANCE PROGRAM - EDUCATION FUNDING - (SNAP-ED) CALFRESH HEALTHY LIVING

The City Council (1) accepted a CalFresh Healthy Living Grant in the amount of \$115,000 and extended the grant term from October 1, 2022, to September 30, 2023; (2) with at least five affirmative votes, authorized an increase in revenue in the amount of \$115,000, or the actual award amount, and appropriated expenditures in the same amount, to the Development Grants Fund, CalFresh Healthy Living Grant revenue and expenditure accounts; and (3) authorized the City Manager, or designee, to execute all necessary grant documents, making minor and non-substantive changes, for the award of a CalFresh Healthy Living Grant.

DECLARE EXEMPT SURPLUS - CITY-OWNED VACANT LAND - SALE AGREEMENT AND JOINT ESCROW INSTRUCTIONS - WILDERNESS/ED PERKIC

The City Council (1) declared a portion of vacant City-owned land bearing APN 189-100-006 as exempt surplus land; (2) approved the Purchase & Sale Agreement and Joint Escrow Instructions with Southern California Edison for: (a) a portion of City-owned land (Assessor's Parcel Number 189-100-006), (b) two easements (portions of Assessor's Parcel Numbers 189-100-006 & 189-090-002 & -010); (3) approved the Cost Sharing Agreement with South California Edison for the Riverside Transmission Reliability Project; (4) authorized the City Manager, or his designee, to execute the Purchase & Sale Agreement and Joint Escrow Instructions, including making minor and non-substantive changes, and to sign all documents necessary to complete the transaction; and (5) authorized the City Manager, or his designee, to execute the Cost Sharing Agreement with South California Edison for the Riverside Transmission Reliability Project, including making minor and non-substantive changes, and to sign all documents necessary.

The City Council (1) received and approved the Annual Report of the Riverside Downtown Partnership, acting in its capacity as the Advisory Board to the Downtown Parking and Business Improvement Area; (2) adopted a Resolution declaring the City of Riverside's intention to levy an annual assessment in the Downtown Business Improvement Area for Calendar Year 2023, from January 1, 2023, through December 31, 2023; and (3) scheduled a public hearing for November 8, 2022, at 3:00 p.m. in the Art Pick Council Chamber on the levy of the proposed assessment; whereupon, the title having been read and further reading waived, Resolution No. 23908 of the City Council of the City of Riverside, California, Declaring Its Intention to Levy an Annual Assessment in the Downtown Parking and Business Improvement Area for Calendar Year 2023 Pursuant to Section 36534 of the California Streets and Highways Code, Generally Describing the Improvements and Activities to be Undertaken and Fixing the Time and Place for a Public Hearing Before the City Council of the City of Riverside on the Levy of the Proposed Assessment, was presented and adopted.

BID 7926 - PURCHASE, REMOVAL, AND INSTALLATION OF APC BATTERY MODULES The City Council (1) awarded Bid 7926 for the purchase, removal, and installation of an American Power Conversion battery modules to Donovon Distribution, Inc., doing business as UPS Protection, in the amount of \$55,314.60; and (2) authorized the City Manager, or designee, to execute the Professional Consulting Services Agreement, and any supplementary documentation to effectuate and enforce this agreement, including making minor and non-substantive changes.

AGREEMENT - SAN BERNARDINO COUNTY SHERIFF, CORONER, AND PUBLIC ADMINISTRATOR WEAPONS FIRING RANGE FACILITIES FOR POLICE TRAINING The City Council (1) approved the Agreement between the County of San Bernardino and the City of Riverside for use of the San Bernardino County Sheriff, Coroner, and Public Administrator weapons firing range facilities from Fiscal Year 2022-23 through Fiscal Year 2026-27 in the total amount of \$75,000; and (2) authorized the City Manager, or designee, to execute all necessary documents and approve future addendums to the Agreement.

FISCAL YEAR 2022-23 -GAGE CANAL COMPANY'S CAPITAL EXPENDITURE BUDGET The City Council approved the Gage Canal Company's capital expenditure budget of \$103,000 for Fiscal Year 2022-23.

FINAL TRACT MAP 37626 - TYLER/JURUPA - RESOLUTION

The City Council (1) adopted the Resolution of Acceptance for final approval of Tract Map No. 37626; and (2) accepted the agreement and sureties for the installation and faithful performance of improvements and the labor and material bond in accordance with the improvement plans for the development of Tract Map No. 37626; whereupon, the title having been read and further reading waived, Resolution No. 23910 of the City Council of the City of Riverside, California, Accepting the Final Map of Tract No. 37626, was presented and adopted.
