11	governing body to declare by resolution certain authorizations related to the administration of Program

15	available funds on behalf of the City available under the Department's Program, and carryout all other

22	Section 2: The City Manager, or designee, ("Authorized Representative") is hereby authorized
23	and empowered to execute on behalf of the City all necessary documents, including but not limited to
24	a funding agreement, applications, payment requests, invoices, progress reports, agreements and
25 26	amendments thereto, necessary to secure grant funds and to implement the approved grant project.
26	Section 3: The Authorized Representative, is designated to provide the assurances,
27	certifications, and commitments required for the grant funding application, including executing a
28 IEY'S OFFICE	funding agreement from the California Department of Water Resources and any amendments or
