BOARD AND COMMISSION RESIGNATION

The Mayor and City Council accepted the resignation of Rochelle P. Motley-Kanatzar from the Human Relations Commission Citywide seat effective immediately.

MINUTES

LEASE AMENDMENT - RENOVATIONS AND IMPROVEMENTS TO RIVERSIDE ACCESS CENTER CLINIC FOR HOMELESS INDIVIDUALS AND LOW-INCOME HOUSEHOLDS - 2880 HULEN

The City Council (1) approved the Second Amendment to Lease by and between The City of Riverside and The Regents of University of California Riverside Medical School California to complete renovations and improvements to the Riverside Access Center clinic space and new entrance located at 2880 Hulen Place to provide outpatient medical services for homeless individuals and low-income households; and (2) authorized the City Manager, or his designee, to execute the Second Amendment to Lease with The Regents of the University of California, including making minor and non-substantive changes, and to sign all documents and instruments necessary to implement this action, including making minor and non-substantive changes.

AGREEMENTS AMENDMENTS - OPERATION AND MANAGEMENT - FOX PERFORMING ARTS CENTER AND RIVERSIDE MUNICIPAL AUDITORIUM

The City Council (1) approved the First Amendment to Management Agreement with Live Nation Worldwide, Inc., for the Fox Performing Arts Center through June 30, 2023; (2) approved the First Amendment to Management Agreement with Live Nation Worldwide, Inc., for the Riverside Municipal Auditorium through June 30, 2023; and (3) authorized the City Manager, or his designee, to execute any necessary financial, or legal documents, including making minor and non-substantive changes to execute the agreements.

FISCAL YEAR 2022-23 AND FISCAL YEAR 2023-24 - ARTS AND CULTURE GRANT PROGRAM AWARDS

The City Council (1) approved staff recommendations and administration of the Arts & Culture Grants Program for Fiscal Year 2022-23 in the amount of \$291,369; and Fiscal Year 2023-24 in the amount of \$294,283; and (2) authorized the City Manager, or his designee, to execute any necessary, financial, or legal documents with the approved

organizations and/or artists, including making minor and non-substantive changes, to implement the City's Arts & Culture Grant Program for arts & culture organizations.

CASE PR-2022-001422 - TITLE 20 TEXT AMENDMENT - MILLS ACT APPLICATIONS - MILLS ACT HISTORIC PRESERVATION CONTRACT APPLICATION PROCESS - ORDINANCE INTRODUCED - RESOLUTION

The City Council (1) determined that Planning Case PR-2022-001422 is exempt from further California Environmental Quality Act (CEQA) review pursuant to Sections 15308 (Actions to Protect Environment), 15060(c)(2) (No Physical Change), 15060(c)(3) (Not A Project), and 15061(b)(3) (General Rule), as the proposed amendment will cause no direct or indirect change to the environment, does not meet the definition of a Project under CEQA, and it can be seen with certainty that the proposed amendment will not have an effect on the environment; (2) approved Planning Case PR-2022-001422 – Title 20 (Cultural Resources) Text Amendment amending the application period of the Mills Act from the month of June to January 1 – May 31 of each calendar year; (3) introduced an Ordinance amending Title 20 (Cultural Resources) of the Riverside Municipal Code; and (4) approved and adopted a Resolution amending Resolution No. 20825, thereby increasing the number of Mills Act applications accepted to an average of fifteen and a maximum of twenty each year and reflecting the application timeframe consistent with the proposed amendment to Title 20 (Cultural Resources); whereupon an Ordinance entitled “An Ordinance of the City of Riverside, California, Amending Sections 20.30.020 and 20.30.030 of the Riverside Municipal Code Regarding The Mills Act Program and Historic Preservation Fund,” was presented and introduced, and whereupon, the title having been read and further reading waived, Resolution No. 23921 of the City Council of the City of Riverside, California, Amending Resolution No. 20825 to Change the Mills Act Historic Preservation Contract Application Process Including the Application Period and Number of Contract Applications Accepted and Processed, was presented and adopted.

REVISIONS TO HUMAN RESOURCES POLICY AND PROCEDURE MANUAL

The City Council adopted the proposed revisions to the City's personnel policies contained in the Human Resources Policy and Procedure manual including Travel Time Compensation, Appointment and Selection of City Attorney Classifications and Salary Placement, Drug-free Workplace, Unpaid Voluntary Furlough, and Deferred Compensation policies.

REQUEST FOR PROPOSAL 2159 - AGREEMENT - WATER QUALITY LABORATORY TESTING AND ANALYTICAL SERVICES

The City Council (1) approved a Professional Consultant Services Agreement with Babcock Laboratories, Inc., Riverside, from Request for Proposal 2159, for water quality laboratory testing and analytical services for a three-year term until June 30, 2025, in the amount of \$3,000,000 with two optional one-year extensions in an annual amount of \$1,000,000; (2) authorized the City Manager, or designee, to execute the Agreement, including the two optional one-year extensions, and making minor and non-substantive changes; (3) ratified emergency Purchase Order No. 232444 in the amount of \$49,500 with Babcock Laboratories, Inc.; and (4) authorized the City Manager, or designee, to execute all documents related to the termination of the current Professional Consultant Services Agreement with Eurofins Eaton Analytical, LLC.

AGREEMENT AMENDMENT - MUNICIPAL PRESSURE WASHING AND CLEANING SERVICES - CITYWIDE

This item was removed from the agenda.

AGREEMENT AMENDMENT - SYCAMORE HIGHLANDS LANDSCAPE MAINTENANCE DISTRICT AND CANYON SPRINGS/CANYON CROSSINGS BUSINESS DISTRICT

The City Council (1) approved a First Amendment to the Landscape Maintenance Services Agreement with Greentech Landscape, Inc., Whittier, for landscape and general outside maintenance services for Sycamore Highlands Landscape Maintenance District and Canyon Springs/Canyon Crossings Business District, retroactively, from July 1, 2022, to June 30, 2023, in the amount of \$157,510.47, including 10 percent contingency for vandalism, theft, and/or decay, for a total amount of \$601,005.47, and with one optional one-year extension; (2) authorized the City Manager, or designee, retroactively, to execute the First Amendment to the Services Agreement, including making minor and non-substantive changes; and (3) authorized the City Manager, or designee, to execute the optional one-year extension, provided that the amount is included in the subsequent approved budgets.

DISCUSSION CALENDAR

RECONSIDER CIRCUMSTANCES OF THE STATE OF EMERGENCY AND MAKE A FINDING THAT STATE AND/OR LOCAL OFFICIALS CONTINUE TO RECOMMEND SOCIAL DISTANCING MEASURES

Following discussion, it was moved by Councilmember Cervantes and seconded by Councilmember Edwards to (1) reconsider the circumstances of the state of emergency; and (2) make a finding (a) that the state of emergency continues to directly impact the ability of its members to safely meet in person, and (b) that state and/or local officials continue to recommend or impose social distancing measures to continue to meet via teleconference. The motion carried with Councilmembers Edwards, Cervantes, Fierro, Hemenway and Councilwoman Plascencia voting aye and Councilmembers Conder and Perry voting no.

BID 7876 - SENATE BILL 1 MAINTENANCE AND TRAFFIC IMPROVEMENTS PHASE 2 - CITYWIDE
Following discussion, it was moved by Councilmember Conder and seconded by Councilmember Hemenway (1) award construction contract for Bid 7876 for Fiscal Year 2019/20 SB-1 Maintenance and Traffic Improvements Phase 2 to All American Asphalt, Corona, in the amount of \$4,311,788; and (2) authorized the City Manager, or designee, to execute the construction contract, including making minor and non-substantive changes. The motion carried with Councilmembers Edwards, Cervantes, Fierro, Conder, Hemenway, and Councilwoman Plascencia voting aye and Councilmember Perry abstaining citing real property conflict of interest.

MEASURE Z - BID 7907 - ARTERIAL AND MINOR STREETS MAINTENANCE, PHASE 1 - CITYWIDE
Following discussion, it was moved by Councilmember Conder and seconded by Councilmember Perry to (1) award a construction contract for Bid 7907 for Fiscal Year 2021/22 Arterial and Minor Streets Maintenance, Phase 1 to Onyx Paving Company, Inc., Anaheim, in the amount of \$6,472,000; and (2) authorize the City Manager, or designee, to execute the construction contract, including making minor and non-substantive changes. The motion carried unanimously.

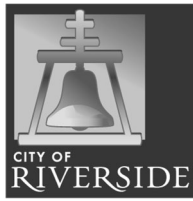
