A RESOLUTION OF THE CITY COUNCIL OF THE CITY **ACCEPTING** RIVERSIDE, CALIFORNIA, THE **STATE** CALIFORNIA, DEPARTMENT OF ALCOHOLIC BEVERAGE CONTROL ABC-OTS LOCAL ENFORCEMENT GRANT AWARD TO INCREASE **ACTIVITY** ENFORCEMENT IN RELATION TO BEVERAGE CONTROL (ABC) VIOLATIONS; AND AUTHORIZING THE EXECUTION OF THE NECESSARY DOCUMENTS BY THE CITY MANAGER, OR HIS DESIGNEE.
