TCC Grant	295 trees have been planted and an additional 60 trees to be planted by the end of the year. 100 fruit trees were distributed at a Trick-or-Tree Event. There are four (4) more planting events scheduled for this year. The xeriscaping project is underway with four (4) approved applications and five (5) more are under review. Sixteen (16) applications have been received for solar installation and five (5) applications have been approved. A showcase event for the first installation will take place in December. The next construction workforce cohort will take place on December 6th. Housing workshops are scheduled for November 8th and 17th. The eight invoice and progress report have been submitted and the ninth is in progress. There are two ongoing Resident Leadership Academy cohorts focusing on the TCC projects with seven (7) participants in the English cohort and 17 participants in the Spanish cohort. TCC partners will present to each cohort in November and a symposium for their graduation and presentation on the projects will occur in January. Project was runner up for an Inland Empire Economic Partnership Sustainable Development Award.
