SUBJECT: PAINTING OF SIX TRAFFIC SIGNAL CABINETS WITH ARTISTIC FEATURES

ON RIVERWALK PARKWAY

ISSUE:

Consideration of painting six traffic signal cabinets with artistic features on Riverwalk Parkway between Pierce Street (S) and Pierce Street (N).

RECOMMENDATION:

That the Mobility & Infrastructure Committee recommend that the City Council approve the Public Works Department's request to seek competitive bids and/or quotes from local artists to paint six traffic signal cabinets on Riverwalk Parkway between Pierce Street (S) to Pierce Street (N).

BACKGROUND:

The City of Riverside's vision is "to inspire everyone through meaningful arts and cultural experiences." The Downtown area has numerous examples of artistic displays that the public can enjoy such as murals on private property walls, Mariposa Alley, incorporation of artistic elements into new building construction, prominent statues along the Main Street Pedestrian Mall, and other artistic features that attract residents and visitors to Downtown. Public art adds value to the cultural, aesthetic, and economic vitality of a community and many residents only experience art within public space. The City is home to exceptional artistic talent and public art affords opportunities for artists to showcase their gift which cultivates an environment for creative individuals to thrive.

Public art within neighborhoods or highly visited locations can be an investment in placemaking which is measured by the livability and quality of life but can also engender community pride. The Public Works Department services nearly 400 traffic signals citywide and each signal is supported by a signal controller/equipment housed in a signal cabinet. Most traffic signal cabinets are located near the intersection and are visible to motorists, bicyclists, and pedestrians and are excellent locations for public art.

DISCUSSION:

In April 2022, the Public Works Department collaborated with volunteers from Sandals Church to paint twelve traffic signal locations as listed in Table 1.

The project has been well received by the community and below are a few images of some of the painted cabinets.











After successful implementation of the 12 painted signal cabinets, the president of the Riverwalk

Homeowners Association reached out to staff requesting similar support for the cabinets located on Riverwalk Parkway. The Riverwalk community includes amenities encouraging increased walking via meandering sidewalks, delineated bike lanes, water features, a dog park, benches, exercise areas, and gazebos. Public art along Riverwalk Parkway would foster community pride and add public art to the westerly part of the City. The Riverwalk HOA conducted surveys on the type of graphic art they would like to see and residents responded with the following:

- 1. Active Lifestyle Images (Fitness, Dog Walking, Biking, Walking, Jogging) 45%
- 2. Local Wildlife (Fish, Ducks, Birds, etc.) 27%
- 3. Colorful Landscape Scenes 23%
- 4. Other 5%

Given the positive feedback with the initial painting of the traffic signal cabinets, staff is supportive of partnering with local artists to paint traffic signal cabinets on Riverwalk Parkway at:

- 1. Pierce Street (S) just north of the 91 Freeway
- 2. Flat Rock Road
- 3. Collett Avenue
- 4. Yeager Drive (Entrance to La Sierra University)
- 5. Sierra Vista Avenue
- 6. Pierce Street (N)

This project would differ from the volunteer efforts by the Sandals Church team in that the Public Works Department would select specific paints and coating materials for pilot testing purposes and conduct planned durability reviews following project implementation. After the pilot, Public Works Department and Community & Economic Development – Arts & Cultural Affairs will make any changes and then will implement citywide, budgetary permitting.

Artists can provide a common theme, paint the cabinets to complement community features, encourage increased walking by displaying unique and thoughtful art, and/or attract visitors to this area. The public art would also allow staff to leverage this project to pursue grant funds or consider a program to expand art displays within the public right-of-way. Hand painting the traffic signal cabinets provides unique displays but also allows the Public Works Department to assess their maintenance and longevity as the cabinets are exposed to direct sunlight, wind, rain, and elements impacting the aesthetics over time. If maintenance becomes a concern, the Public Works Department has the option of requesting artists to work with specialized companies to transfer their artwork onto "wrap" material which may weather better and facilitate cleanup efforts although the wrap material requires increased investment.

Staff from the Public Works Department and Riverside Public Utilities met with local artists to consider the project, assess implementation schedule, cost, materials, maintenance requirements, and share examples from other agencies to select project components for successful implementation. Staff would also collaborate with Community & Economic Development - Arts & Cultural Affairs staff to work with the artists to share the City's goals, engage the Riverwalk HOA, and provide supporting direction to the artists.

The Community & Economic Development - Arts & Cultural Affairs Manager concurs with this report.

STRATEGIC PLAN ALIGNMENT:

This item contributes to **Strategic Priority 1 – Arts, Culture and Recreation** and **Goal 1.1** – Strengthen Riverside's portfolio of arts, culture, recreation, senior, and lifelong learning programs and amenities through expanded community partnerships, shared use opportunities and fund development, and **Goal 1.2** – Enhance equitable access to arts, culture, and entertainment and recreational service offerings and facilities. It also contributes to **Strategic Priority 2 – Community Well-Being** and **Goal 2.3** – Strengthen neighborhood identities and programs that foster an increased sense of community and enhanced feelings of pride and belonging citywide.

The project aligns with each of the five Cross-Threads:

- 1. **Community Trust** The Public Works Department has engaged the Riverwalk Homeowners Association to discuss the potential for painting the traffic signal cabinets and obtained community feedback on the themes and types of art they would like to see.
- 2. **Equity** Completion of public art in Ward 7 promotes geographic equity in the City's facilitation of public art, and the Public Works Department will continue to seek avenues to deploy public artwork Citywide.
- 3. **Fiscal Responsibility** The Public Works Department would work with local artists to secure competitive bids for the project.
- 4. **Innovation** This project will be used to assess the durability of the paint materials, obtain feedback from the community on these types of projects, and consider a program that paints a number of traffic signal cabinets each year.
- **5. Sustainability & Resiliency** Each traffic signal cabinet would include a graffiti removal clear coating to facilitate maintenance. Further, the City may elect to secure a maintenance plan to address damage to the paintings or request touchup work for areas that may fade or may be impacted by weather.

FISCAL IMPACT:

There is no fiscal impact with this report. Based on preliminary estimates, the total cost of the project following a competitive bidding or quotation process is unlikely to require Public Works to return for Council approval as there should be funds available to cover any minimal costs.
