Following discussion, it was moved by Member Hemenway and seconded by Chair Fierro to (1) receive and order filed an update on the City-owned land located at 3911 University Avenue and 3775 Fairmount Boulevard, identified as Assessor Parcel Numbers 214-252-016 & 213-261-027 (former downtown Terminal) for the development of a mixed-use student housing project for the Riverside Community College District (RCCD); and (2) direct staff to not issue a new Request for Proposal (RFP) for the subject site and proceed with original proposal from Overland Pelican Riverside, LLC. The motion carried with Chair Fierro and Member Hemenway voting Aye and Vice Chair Edwards voting No.


DECARBONIZATION AND ELECTRIFICATION UPDATE
