## THIRD AMENDMENT TO PROFESSIONAL CONSULTANT SERVICES AGREEMENT

## ENVIRONMENTAL LOGISTICS, INC.

Hazardous Waste Services (RFP No. 1954)

THIS THIRD AMENDMENT TO PROFESSIONAL CONSULTANT SERVICES AGREEMENT ("Third Amendment") is made and entered into this 21st day of September , 2022, by and between the CITY OF RIVERSIDE, a California charter city and municipal corporation ("City"), and ENVIRONMENTAL LOGISTICS, INC., a California corporation ("Consultant"), with respect to the following:

## **RECITALS**

WHEREAS, the City and Consultant entered into that certain Professional Consultant Services Agreement dated November 19, 2019 ("Agreement"); and

WHEREAS, the City and Consultant entered into that certain First Amendment to Professional Consultant Services Agreement dated June 2, 2020 ("First Amendment"); and

WHEREAS, the City and Consultant entered into that certain Second Amendment to Professional Consultant Services Agreement dated May 4, 2021 ("Second Amendment"); and

WHEREAS, the Agreement is set to expire on June 30, 2023; and

WHEREAS, during the past fiscal year, the City has had need of Consultant's services in a capacity greater than initially anticipated, and anticipates that the need will continue through the rest of the contract term; and

WHEREAS the City and Consultant would like to increase compensation amount by Two Hundred Fifty Thousand Dollars (\$250,000.00), for a new total contract amount not to exceed One Million Seven Hundred Fifty Thousand Dollars (\$1,750,000.00), for the remainder of the term of the Agreement.

NOW, THEREFORE, incorporating the recitals set out above, the parties hereto mutually agree to the following amendment to the Agreement.

- 1. Section 3, Compensation/Payment, is hereby amended to increase the compensation amount by Two Hundred Fifty Thousand Dollars (\$250,000.00), for a new total contract amount not to exceed One Million Seven Hundred Fifty Thousand Dollars (\$1,750,000.00).
- 2. All other terms and conditions of the Agreement, First Amendment and Second Amendment between the parties, which are not inconsistent with the terms of this Third Amendment, shall remain in full force and effect as if fully set forth herein.
