LOCATION: 2998 Ivy Street and 3399 Central Avenue,


situated on the south side of Ivy Street, west of Rockhill Way and East of State

Route 91, in Ward 3.

PROPOSAL: To consider the following entitlements to expand an existing commercial self-storage facility by 158 units: (1) General Plan Amendment to amend the Plan 2025 land use designation approximately 1.51-acres from LDR – Low Density Residential to C - Commercial; (2) Rezone to amend the zoning designation of approximately 1.62-acres from R-1-7000 - Single Family Residential to CG-CS -Commercial General and Commercial Storage overlay zones; (3) Design Review of project plans; and (4) Variance to allow a 6-foot high fence, around the perimeter of the property, where the Zoning Code requires a 6-foot high wall. The 8.22-acre site consists of four contiguous parcels, of which 6.6-acres are fully developed with an existing self-storage facility.

ENVIRONMENTAL DETERMINATION: The Community and Economic Development Department recommends that the City Council determine that the proposed project will not have a significant effect on the environment based on the findings set forth in the case record and adopt a Mitigated Negative Declaration and Mitigation Monitoring and Reporting Program (MMRP) pursuant to CEQA Sections 15074 and 21081.6.
