## EIGHTH AMENDMENT TO AGREEMENT FOR UNARMED SECURITY GUARD SERVICES AT VARIOUS CITY FACILITIES

## UNIVERSAL PROTECTION SERVICE, LP dba ALLIED UNIVERSAL SECURITY SERVICES (Unarmed Security Services)

THIS EIGHTH AMENDMENT TO PROFESSIONAL CONSULTANT SERVICES AGREEMENT ("Eighth Amendment") is made and entered into this \_\_\_\_\_\_ day of \_\_\_\_\_\_, 2022 by and between the CITY OF RIVERSIDE ("City"), a California charter city and municipal corporation and UNIVERSAL PROTECTION SERVICE, LP, a California limited partnership doing business as Allied Universal Security Services ("Contractor").

## RECITALS

WHEREAS, on August 12, 2015, City and Contractor's predecessor in interest, Guardsmark GP, entered into an Agreement for Unarmed Security Guard Services at Various City Facilities; and

WHEREAS, on February 23, 2016, City and Contractor entered into a First Amendment to Agreement for Unarmed Security Guard Services at Various City Facilities wherein Contractor agreed to assume all rights and obligations from Guardsmark GP under the Agreement ("First Amendment"); and

WHEREAS, on September 27, 2016, City and Contractor entered into a Second Amendment to Agreement for Unarmed Security Guard Services at Various City Facilities to add additional facilities and modify other facility; and

WHEREAS, on May 18, 2017, City and Contractor entered into a Third Amendment to Agreement for Unarmed Security Guard Services at Various City Facilities to increase the services at existing facilities, to add new facilities and services, and to increase the compensation; and

WHEREAS, on June 25, 2018, City and Contractor entered into a Fourth Amendment to Agreement for Unarmed Security Guard Services at Various City Facilities to increase the services at existing facilities, to add new facilities and services, and to increase the compensation; and

WHEREAS, on July 8, 2019, City and Contractor entered into a Fifth Amendment to Agreement for Unarmed Security Guard Services at Various City Facilities to amend the Agreement to extend the term by one (1) year; and

WHEREAS, on August 24, 2020, City and Contractor entered into a Sixth Amendment to Agreement for Unarmed Security Guard Services at Various City Facilities to amend the Agreement to extend the term by one (1) year (Collectively the Agreement and all subsequent amendments will hereinafter be referred to as "Agreement"); and

WHEREAS, on June 3, 2021, City and Contractor entered into a Seventh Amendment to Agreement for Unarmed Security Guard Services at Various City Facilities to amend the Agreement to extend the term by one (1) year; and

WHEREAS, City and Contractor desire to amend the Agreement to extend the term to February 28, 2023, with additional Compensation of Nine Hundred Forty Thousand Four Hundred Five Hundred Forty-Eight Dollars and Eight Cents (\$940,548.08).

NOW THEREFORE in consideration of the foregoing recitals, which are incorporated herein by this reference, City and Contractor agree as follows:

1. Section 2, Term of the Agreement, is amended to extend the term to expire on February 28, 2023.

2. Section 3, Compensation is amended to add Nine Hundred Forty Thousand Five Hundred Forty-Eight and Eight Cents (\$940,548.08) for the period July 1, 2022, through February 28, 2023 in accordance with **Exhibit "B-8"** attached hereto and incorporated herein.

3. All terms and conditions of the Agreement not inconsistent herewith shall remain in full force and effect, and are hereby incorporated by reference into this Eighth Amendment as though set forth in full herein.
