In the City of Riverside, County of Riverside, State of California, those portions of Lots 277, 277a, 277b, 278, 278a, 278b, Lot "M"(vacated) and Lot "N"(Vacated) of Camp Anza Subdivision No. 1, in the City of Riverside, County of Riverside, State of California, as per Map recorded in Book 22 Pages 81 and 82 of Maps, in the Office of the County Recorder of said County, Rancho La Sierra-Supulveda, protracted Section 1, T3S, R6W.

"Lot A" is hereby accepted for public street purposes subject to the installation of improvements to the satisfaction of the Public Works Director of the City of Riverside;

"Lot A" is hereby accepted for public utility purposes and other public services;

The easements designated as "Blanket P.U.E." are hereby accepted as easements for the construction and maintenance of electric energy distribution and telecommunication facilities.

- 4. The City of Riverside, successor in interest to that certain easement granted to La Granada Water Company, a corporation for water transmission and distribution facilities and lines recorded January 5, 1960 as Instrument No. 537, in Book 2609, Page 449 of Official Records, Riverside County.
- 5. The City of Riverside, successor in interest to that certain easement granted to Southern California Edison Company for electric line, consisting of poles, necessary guys and anchors, cross-arms, wires and other fixtures and appliances recorded August 24, 1960 as Instrument No. 74707, in Book 2755, Page 81 of Official Records, Riverside County.

The City of Riverside, successor in interest to that certain easement granted to Southern California Edison Company for electric line, consisting of poles, necessary guys and anchors, cross-arms, wires and other fixtures and appliances recorded February 8, 1961 as Instrument No. 11038, in Book 2846, Page 156 of Official Records, Riverside County.

The City of Riverside, successor in interest to that certain easement granted to Southern California Edison Company for electric line, consisting of poles, necessary guys and anchors, cross-arms, wires and other fixtures and appliances recorded May 31, 1962 as Instrument No. 50917, in Book 3151, Page 368 of Official Records, Riverside County.

8. That certain easement granted to the City of Riverside for electric energy distribution and telecommunication facilities, together with all necessary appurtenances recorded April 9, 2008 as Instrument No. 2008-0175397 of Official Records, Riverside County.
