

ABERNATHY DRIVE AND PERTHSHIRE PLACE TEMPORARY CUL-DE-SAC PILOT PROJECT

BACKGROUND

- Residents on Perthshire Place raised concerns regarding ongoing impacts to their neighborhood generated by adjacent Sycamore Highlands Park including:
 - 1.Increased traffic volumes and speeds;
 - 2. Overflow parking and parking violations within the posted Preferential Parking Zone (PPZ);
 - 3. Elevated noise levels and late hour noise;
 - 4. Litter, trash and debris;
 - 5. After-hours park use; and
 - 6. Illegal and illicit activities.



BACKGROUND (CONTINUED)

- Residents have worked with:
- 1. The Public Works Department to implement a Preferential Parking Zone (PPZ) on Perthshire Place to preserve availability of on-street parking for residents and their guests;
- 2. The Parking Services Division and Riverside Police Department to enforce area parking regulations;
- 3. The Riverside Police Department to address illegal and illicit activity and after-hours park use; and
- 4. Ward 2 City Council's Office to discuss community concerns and explore solutions.




BACKGROUND (CONTINUED)

- Residents indicate that Sycamore Highlands Park:
 - 1. Was designed for local walking community use;
 - 2. Is not equipped with a parking lot requiring onstreet patron parking;
 - 3. Has experienced an increase in use by patrons from outside of the local community; and
 - 4. Is negatively impacting the quality of life for neighboring Perthshire Place residents.

POTENTIAL TEMPORARY PILOT PROJECT

- 100% of Perthshire Place residents petitioned the City to implement a temporary cul-de-sac 6-month pilot project on Abernathy Drive at Perthshire Place;
- Residents also requested to close pedestrian access at the sidewalk connection between Perthshire Place and Abernathy Drive to further deter illegal parking and walking to and from the park;
- The Public Works Department supports creative alternatives to mitigate traffic and parking impacts with consideration to overall impacts.

PILOT PROJECT DETAILS



PILOT PROJECT BENEFITS

- Enables use of temporary materials to allow for assessment of effectiveness prior to implementing more costly permanent improvements;
- Allows for residents to experience actual effects;
- Provides resulting traffic and parking data;
- Ensures ample time to obtain public input; and
- Permits emergency and service provider additional assessment prior to considering pilot extension and/or permanent improvements.



POTENTIAL IMPACTS

- Delays in emergency vehicle response times and repositioning during an incident;
- Limits to access require altered routes for emergency and service vehicles and immediate area residents;
- Insufficient turning radius necessitating Fire, Solid Waste, and Street Sweeping vehicles to back-up to exit creating safety concerns;
- Shifting of traffic and/or parking to other area streets;
- Creates need for non-standard quarterly hand street cleaning at an increased associated cost; and
- Results in temporary loss of 6 to 7 on-street parking spaces.
