BACKGROUND


- Residents have reported cut-through truck traffic coming from Cajalco Road traveling through La Sierra Avenue to travel onto the 91 Freeway.
- The Public Works Department may establish weight limit or axle restrictions to prohibit use of select streets by larger commercial vehicles.
- Proposed axle limit restrictions assist in preserving the pavement, improve safety on residential streets.

DISCUSSION

- The Public Works Department is proposing establishment of an axle restriction prohibiting use by commercial trucks exceeding three axles in both directions on La Sierra Avenue from the southerly City limits to the SR-91 Freeway.
- The Axle restriction is recommended based on classification count data performed which resulted in the percentage of truck traffic above the maximum 3% truck traffic threshold (3.8%).

DISCUSSION

- The proposed axle restriction will address cut-through commercial truck traffic utilizing this segment of La Sierra Avenue to bypass the I-15 Freeway and SR-91 Freeway Junction.
- The City coordinated with the County of Riverside to install additional advance signage at the intersections of Cajalco Road at La Sierra and El Sobrante at La Sierra.



- On December 8, 2022 the Mobility & Infrastructure Committee reviewed the proposed axle restriction prohibiting use by commercial vehicles exceeding three axles on La Sierra Avenue from the southerly City limits to the SR-91 Freeway.
- The Committee voted unanimously to recommend establishment of the proposed axle restriction.
