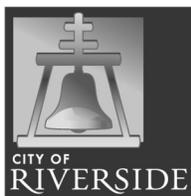

CONSENT CALENDAR

It was moved by Councilmember Hemenway and seconded by Councilmember Perry to approve the Consent Calendar as presented affirming the actions appropriate to each item. The motion carried with (1) Councilmembers Edwards and Cervantes voting no on adopting an ordinance to rezoning Sycamore Canyon Business Park at 2610 E Alessandro Boulevard; and (2) Councilmember Conder (a) abstaining on the outside counsel budget in the case of Tony Platt v City of Riverside, and (b) voting no on circumstances of the state of emergency and continue to recommend or impose social distancing measures to meet via teleconference.

OUTSIDE COUNSEL BUDGET

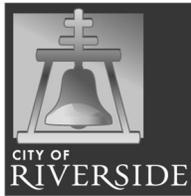

PAINTING SIX TRAFFIC SIGNAL CABINETS - RIVERWALK/PIERCE

The City Council approved the Public Works Department's request to seek competitive bids and/or quotes from local artists to paint six traffic signal cabinets on Riverwalk Parkway between Pierce Street (S) to Pierce Street (N).

ESTABLISH AXLE RESTRICTIONS - LA SIERRA AVENUE/STATE ROUTE 91 - ORDINANCE INTRODUCED

The City Council introduced an Ordinance amending Section 10.56.050 of the Riverside Municipal Code to establish an axle restriction prohibiting use by commercial vehicles exceeding three axles on La Sierra Avenue from the southerly City limits to the SR-91 Freeway; whereupon an ordinance entitled "An Ordinance of the City of Riverside, California, Amending Section 10.56.050 of the Riverside Municipal Code to Establish Axle Restrictions on La Sierra Avenue," was presented and introduced.

The City Council adopted an Ordinance amending the Zoning Map of the City of Riverside pursuant to Chapter 19.090 of the Riverside Municipal Code by rezoning approximately 1.62 acres of property located at 2998 Ivy Street and 3399 Central Avenue from R-1-7000 - Single Family Residential and CG - Commercial General to CG-CS - Commercial General and Commercial Storage Overlay Zones; whereupon, the title having been read and further reading waived Ordinance No. 7619 of the City Council of the City of Riverside, California, Amending the Zoning Map of the City of Riverside Pursuant to Chapter 19.090 of the Riverside Municipal Code by Rezoning Approximately 1.62 Acres of Property located at 2998 Ivy Street and 3399 Central Avenue from R-1-7000 - Single Family Residential and CG - Commercial General to CG-CS - Commercial General and Commercial Storage Overlay Zones, was presented and adopted.

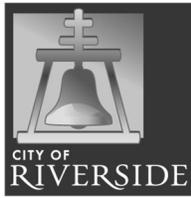

The City Council (1) adopted a Resolution to declare as surplus property approximately 1.25 acres of City-owned vacant land located near the intersection of Jurupa Avenue and Van Buren Boulevard (Property), Assessor Parcel Number (APN) 163-300-018, which is a portion of the Water Quality Control Plant; and (2) authorized the marketing and sale of the above Property at fair market value pursuant to Assembly Bill 1486 and in accordance with the City's Administrative Manual Section 08.003.00 for the Disposition and Sale of City-Owned Real Property; whereupon, the title having been read and further reading waived, Resolution No. 23945 of the City Council of the City of Riverside, California, Pursuant to Assembly Bill 1486, Declaring as Surplus Vacant City-Owned Land, Located Near the Intersection of Jurupa Avenue and Van Buren Boulevard, APN 163-300-018, Which is a Portion of the Water Quality Control Plant, was presented and adopted.

FISCAL YEAR 2022 URBAN AREA SECURITY INITIATIVE (UASI) GRANT PROGRAM - HOMELAND SECURITY PLANNER - FIRE DEPARTMENT - SUPPLEMENTAL APPROPRIATION - RESOLUTION

The City Council (1) adopted a Resolution authorizing a grant application for the Department of Homeland Security's 2022 Urban Area Security Initiative (UASI) grant in the amount of \$3,178,500, or the actual award amount; acceptance of the grant award; and authorization for the City Manager to sign any and all necessary documents for this grant program; (2) authorized a limited term grant funded position in the Fire Department's Office of Emergency Services of Administrative Analyst (working title of Homeland Security Planner) that will be attached to this program; and (3) with at least five affirmative votes, and upon receipt of the grant award, authorized the Chief Financial Officer, or designee, to record an increase in estimated revenues in the amount of \$3,178,500, or the actual amount awarded, and appropriate expenditures in the same

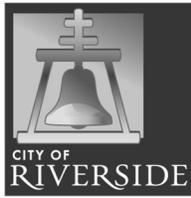
The City Council (1) approved the American Rescue Plan Act Subrecipient Agreement with Path of Life Ministries for \$200,000 of the American Rescue Plan Act funds for the Social Work Internship Program called Love Your Neighbor Collaborative at eight Riverside Public Library locations; and (2) authorized the City Manager, or designee, to execute the American Rescue Plan Act Subrecipient Agreement with Path of Life Ministries, including making minor and non-substantive changes and contract extensions subject to availability of funding.

AGREEMENT AMENDMENT - JANITORIAL SERVICES - CITY PARKS AND COMMUNITY CENTERS

The City Council (1) approved the First Amendment to the Services Agreement with Guaranteed Janitorial Services, Inc., in the amount of \$777,789.90 for janitorial services for the term of January 1, 2023, through June 30, 2024; (2) authorized the City Manager, or designee, to execute a 10% change order authority in the amount of \$77,779.00; and (3) authorized the City Manager, or designee, to execute the Amendment with Guaranteed Janitorial Services, Inc., including making minor and non-substantive changes, amendments, and contract extensions subject to availability of funds.

STATE OF CALIFORNIA CITIZENS' OPTION FOR PUBLIC SAFETY PROGRAM 2023 GRANT AWARD - SUPPLEMENTAL APPROPRIATION

The City Council (1) accepted a grant award from the State of California Citizens' Option for Public Safety program 2023 in the amount of \$490,911, or the actual grant amount, plus a projected interest and growth payment into the Special Deposits Fund, Police State COPS Funding Program; (2) with five affirmative votes, and upon receipt of the grant award, authorized an increase in revenues and appropriation in expenditures in the

PURCHASE AND DELIVERY - JET-A AVIATION FUEL - HELICOPTERS

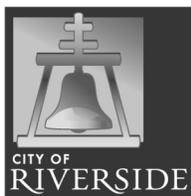
The City Council (1) approved the purchase and delivery of Jet-A Aviation Fuel for City of Riverside helicopters with Epic Aviation, LLC, Salem, Oregon in the total amount of \$150,000 for Fiscal Year 2022/23; (2) approved four optional one-year renewal periods with Epic Aviation, LLC for the purchase and delivery of Jet-A Aviation Fuel products in the amounts of \$165,000 for Fiscal Year 2023/24, \$181,500 for Fiscal Year 2024/25, \$199,650 for Fiscal Year 2025/26, and \$219,615 for Fiscal Year 2026/27 inclusive of 10 percent annual increases for future fuel market volatility; and (3) authorized the City Manager, or designee, to execute all documents pursuant to this purchase including making minor and non-substantive changes, and annual renewal extensions.

LEASE AGREEMENT AMENDMENT - MISSION SQUARE OFFICE - 3750 UNIVERSITY, SUITE 125

The City Council (1) approved the Second Amendment to the Lease Agreement with The IG Group LLC, operating as Slater's 50/50, to extend the Lease Agreement to a 15-year term from January 1, 2021, to December 31, 2036, and adjust the Rent Commencement date from August 22, 2019, to January 1, 2021; and (2) authorized the City Manager, or designee, to execute the Second Amendment, including making minor, non-substantive changes, and to sign all documents and instruments necessary to complete the transaction.

City Attorney Norton announced that the City Council by a 6 - 0 vote, Councilmember Conder recusing citing conflict of interest, authorized the City Attorney's office to seek extraordinary relief from the Court of Appeals based on the trial court's denial of the City's motion to disqualify Plaintiff's counsel in the Tony Platt v City of Riverside case. The disqualification motion was based upon Plaintiff's counsel being in receipt of confidential closed session and attorney client privileged information which is prejudicial to the City and which precludes the City from receiving a fair trial.
