The Community Police Review Commission determined the absence of Commissioner Raya from the January 25, 2023 meeting should be unexcused.


### 2022 Annual Report


### CLOSED SESSION

UPDATES FROM THE CITY MANAGER'S OFFICE  
Manager Megan Stoye reported the following City Council items associated with RPD:

February 7, 2023:

- (1) Purchase and Installation of 23 Flock Falcon Camera Systems in the amount of \$65,550 plus a long-term agreement to renew 40 camera systems annually.


February 14, 2023

- (1) Agreement with Safran Helicopter Engines USA, Inc., for \$2,287,263 For the purchase of two Safran helicopters and complete maintenance through December 31, 2028.

February 21, 2023

- (1) Award Bid 7934 to LOGOS Imaging, LLC., for the amount of \$62,149.06. For the purchase of one X-Ray system to detect improvised explosive devices (IED).
- (2) Approved the Master Fringe Benefits and Salary Plan which included revisions to Relocation Allowance & Incentive programs for certain classifications, which includes some Management, Senior Management, Executive Classifications & difficult to recruit positions. This approval allows for an Incentive Program to be implemented for Police Officer and Public Safety Dispatcher II Lateral Classifications.

Manager Stoye notified the Commissioners that the 2023 NACOLE Conference will be November 12 – 16, 2023.
