A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA ACKNOWLEDGING RECEIPT OF A REPORT MADE BY THE FIRE CHIEF OF THE CITY OF RIVERSIDE FIRE DEPARTMENT REGARDING THE INSPECTION OF CERTAIN OCCUPANCIES REQUIRED TO PERFORM ANNUAL INSPECTIONS PURSUANT TO SECTIONS 13146.2 AND 13146.3 OF THE CALIFORNIA HEALTH AND SAFETY CODE.

WHEREAS, California Health & Safety Code Section 13146.4 was added in 2018, and became effective on September 27, 2018; and,

WHEREAS, California Health & Safety Code Sections 13146.2 and 13146.3 requires all fire departments, including the City of Riverside Fire Department, that provide fire protection services to perform annual inspections in every building used as a public or private school, hotel, motel, lodging house, apartment house, and certain residential care facilities for compliance with building standards, as provided and,

WHEREAS, California Health & Safety Code Section 13146.2 requires all fire departments, including the City of Riverside Fire Department, that provide fire protection services to report annually to its administering authority on its compliance with Sections 13146.2 and 13146.3 and,

WHEREAS, the City Council of the City of Riverside intends this Resolution to fulfill the requirements of the California Health & Safety Code regarding acknowledgment of the City of Riverside Fire Department’s compliance with California Health and Sections 13146.2 and 13146.3.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside that said City Council expressly acknowledges the measure of compliance of the City of Riverside Fire Department with California Health and Safety Code Sections 13146.2 and 13146.3 in the area encompassed by the City of Riverside, as follows:

1 A. EDUCATIONAL GROUP E OCCUPANCIES:

2 Educational Group E occupancies are generally those public and private schools, used by more  
3 than six persons at any one time for educational purposes through the 12th grade. Within the City of  
4 Riverside, there lie 160 Group E occupancies, buildings, structures and/or facilities.

5 During calendar year 2022, the City of Riverside Fire Department completed the annual  
6 inspection of 133 Group E occupancies, buildings, structures and/or facilities. This is a compliance  
7 rate of 83% for this reporting period.

8 Additional items of note regarding this compliance rate can be found in the accompanying staff  
9 report for this resolution.

10 B. RESIDENTIAL GROUP R OCCUPANCIES:

11 Residential Group R occupancies, for the purposes of this resolution, are generally those  
12 occupancies containing sleeping units, and include hotels, motels, apartments (three units or more),  
13 etc. as well as other residential occupancies (including a number of residential care facilities). These  
14 residential care facilities have a number of different sub-classifications, and they may contain residents  
15 or clients that have a range of needs, including those related to custodial care, mobility impairments,  
16 cognitive disabilities, etc. The residents may also be non-ambulatory or bedridden. Within the City  
17 of Riverside, there lie 2380 Group R (and their associated sub-categories) occupancies of this nature.

18 During calendar year 2022, the City of Riverside Fire Department completed the annual  
19 inspection of 2301 Group R occupancies, buildings, structures and/or facilities. This is a compliance  
20 rate of 96% for this reporting period.

21 Additional items of note regarding this compliance rate can be found in the accompanying staff  
22 report for this resolution.
