- On September 11, 2022 the Public Works Department submitted the grant application with a total grant request of \$9M
- On March 14, the California Department of Transportation (Caltrans) informed the City that it's grant application was successful

## HSIP CYCLE XI PROJECT AWARD & OBJECTIVES

City of Riverside HSIP Cycle XI Grant Award:

- Total Project Cost \$9+ Million
- Grant Amount Awarded \$7.8+ Million
- Local Match \$1.2+ Million



HSIP Cycle XI Program Objectives:

- Reduce or eliminate fatal or severe injury traffic collisions at signalized intersections & along Mission Inn Ave

## RECOMMENDATIONS
