


## BACKGROUND

1. Resident quality of life concerns include:
  - a) Increased traffic volumes & speeds;
  - b) Overflow parking & parking violations within the posted Preferential Parking Zone (PPZ);
  - c) Elevated (& late hours) noise levels;
  - d) Litter, trash and debris;
  - e) After-hours park use; and
  - f) Illegal & illicit activities.

## BACKGROUND (CONTINUED)

2. Previously installed a Preferential Parking Zone (PPZ) on Perthshire Place
3. The Parking Services Division & Riverside Police Department enforce area parking regulations
4. The Riverside Police Department works to address illegal and illicit activity & after-hours park use
5. Ward 2 City Council Office - neighborhood meetings to review community concerns & explore solutions.

1. 100% of Perthshire Place residents petitioned to implement a temporary pilot project & create a cul-de-sac restricting vehicle access
2. Multi-departmental collaboration between Public Works, Parks & Rec, Police Dept, Council's Office
3. Minor vehicle turnaround concerns from Fire Dept, Refuse & Street Sweeping
