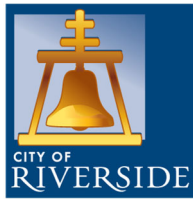

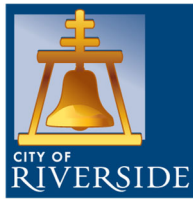

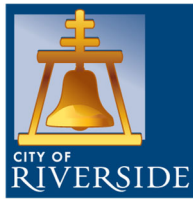

May 16, 2023, at 3:00 p.m. for the purpose of adopting an ordinance granting the Exclusive Franchise for Residential and Commercial Solid Waste, Garbage, Recyclable Material, and Organic Waste Collection Services to Arakelian Enterprises, Inc., doing business as Athens Services, Inc.; (3) adopt a resolution and authorize the issuance of a notice to the current commercial hauling contractors pursuant to Public Resources Code Section 49520 providing for a 5-year continuation of services period and limiting the expansion or solicitation of new business during this time; and (4) reject the proposal from Burrtec Waste Industries, Inc., as non-responsive. The motion failed with Councilmembers Edwards and Cervantes and Councilwoman Plascencia voting aye and Councilmembers Fierro, Conder, Perry, and Hemenway voting no.

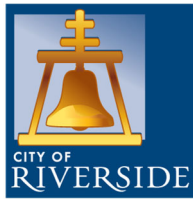

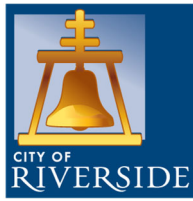

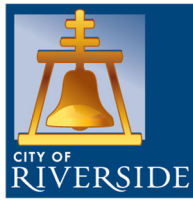
The City Council approved the Mobility and Infrastructure Committee recommendation to approve the temporary cul-de-sac six-month pilot project at the westerly terminus of Abernathy Drive at its intersection with Perthshire Place.

#### REIMBURSEMENT - FIRE DEPARTMENT INSTRUCTIONAL HOURS PER INTER-AGENCY INSTRUCTIONAL SERVICES AGREEMENT - SUPPLEMENTAL APPROPRIATION

The City Council (1) authorized acceptance of training reimbursement funds from Riverside Community College District/Moreno Valley in the amount of \$103,471.38, or in the amount of the grant award; and (2) authorized the Chief Financial Officer, or designee, to record an increase in revenue and an appropriation in expenditures in the amount of the grant award in the Grants and Restricted Programs Fund, Riverside Community College District/Moreno Valley Project accounts.

#### MOBILE BARRIER EQUIPMENT - FIRE DEPARTMENT'S OFFICE OF EMERGENCY MANAGEMENT

#### HEAVY DUTY AERIAL PERSONNEL-LIFT VEHICLE - PUBLIC WORKS TRAFFIC SIGNAL MAINTENANCE DIVISION

The City Council approved the purchase of one heavy duty aerial personnel-lift vehicle from Altec Industries, Inc., Birmingham, Alabama, for the Public Works Traffic Signal Maintenance Division in the amount of \$218,990.

#### MEASURE Z - BID 7908 - FISCAL YEAR 2021-22 ARTERIAL AND MINOR STREETS MAINTENANCE PHASE 2 - CITYWIDE

The City Council (1) awarded Bid 7908 for a construction contract for Fiscal Year 2021-22 Arterial and Minor Streets Maintenance, Phase 2 to R.J. Noble Company, Orange, in the amount of \$10,272,720; and (2) authorized the City Manager, or designee, to execute the construction contract, including making minor and non-substantive changes.

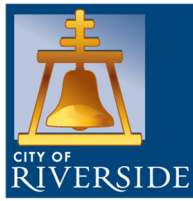
#### BID 7974 - CHANGE ORDER AUTHORITY - GRAVITY SEWER AND FORCE MAIN PIPELINES INSTALLATION ON VAN BUREN

The City Council (1) awarded Bid 7974 for the installation of gravity sewer and force main pipelines on Van Buren Boulevard to E.J. Meyer Company, Yucaipa, California, for a construction contract in the amount of \$7,848,888; (2) approved change order authority for Bid 7974 for the installation of gravity sewer and force main pipelines on Van Buren Boulevard to E.J. Meyer Company in the amount of \$784,888 (10 percent of the contract) for a total contract amount of \$8,633,776; and (3) authorized the City Manager, or designee, to execute the construction contract with E.J. Meyer Company including making minor and non-substantive changes.

#### FEDERAL HIGHWAY SAFETY IMPROVEMENT PROGRAM (HSIP) CYCLE XI GRANT - EQUIPMENT AND IMPLEMENTATION OF PEDESTRIAN SAFETY IMPROVEMENT - MISSION INN/ REDWOOD/SCOUT

The City Council (1) accepted a Federal Highway Safety Improvement Program (HSIP) Cycle XI grant award in the amount of \$7,815,420 to the Public Works Department for the purchase of equipment, implementation of new leading pedestrian interval signal timing, and installation of a median barrier and high friction surface treatment on Mission Inn Avenue between Redwood Avenue and Scout Lane; (2) authorized the City Manager, or designee, to execute all Federal Highway Safety Improvement Program (HSIP) (Cycle XI) Grant Agreements and any related grant documents, making minor corrections as necessary; and (3) authorized the Chief Financial Officer or designee, to

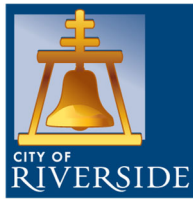
The City Council rejected all bids and released related bid bonds received for Bid 7928, Magnolia Avenue Sewer Force Main Rehabilitation.

#### EMERGENCY WORK - WATER QUALITY CONTROL PLANT GAS LINE REPAIR - 5950 ACORN - RESOLUTION

The City Council (1) adopted a Resolution declaring the emergency natural gas line repairs at the Riverside Water Quality Control Plant an urgent necessity for the preservation of life, health, or property and waiving the formal competitive procurement requirements of the City Charter Section 1109 and authorizing the expenditure in the amount of \$62,732.51 to A.M. Ortega Construction, Inc., Lakeside, California, for the emergency repairs, for a total contract amount of \$112,682.51; and (2) authorized the City Manager, or designee, to approve and execute a construction contract with A. M. Ortega Construction, Inc., including making minor and non-substantive changes; whereupon, the title having been read and further reading waived, Resolution No. 23982 of the City of Riverside, California, (1) Declaring that the Emergency Repair Work for the Emergency Work to the WQCP Gas Line to be of Urgent Necessity for the Preservation of Life, Health, or Property and Waiving the Formal Competitive Procurement Requirements of City Charter Section 1109; and (2) Authorizing the Expenditure in the Amount of \$112,682.51 to A.M. Ortega Construction, Inc., for the Emergency Repairs, was presented and adopted.

#### FINAL TRACT MAP 37732 - PLANNED RESIDENTIAL DEVELOPMENT - RESOLUTION

The City Council (1) adopted the Resolution of Acceptance for final approval of Tract Map No. 37732; and (2) accepted the agreement and sureties for the installation and faithful performance of improvements and the labor and material bond in accordance with the improvement plans for the development of Tract Map No. 37732; whereupon, the title having been read and further reading waived, Resolution No. 23983 of the City of Riverside, California, was presented and adopted.

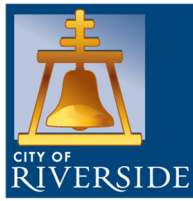
