THIS THIRD AMENDMENT TO PROFESSIONAL CONSULTANT SERVICES AGREEMENT (“Third Amendment”) is made and entered into this 2nd day of ~~April~~ June, 2021, by and between the CITY OF RIVERSIDE, a California charter city and municipal corporation (“City”), and PEAK TECHNICAL SERVICES, INC., a Pennsylvania corporation authorized to business in California (“Consultant”), with respect to the following:

RECITALS

WHEREAS, the City and Consultant entered into that certain Professional Consultant Services Agreement, dated June 12, 2018 (“Agreement”); and

WHEREAS, the City and Consultant entered into that certain First Amendment to Professional Consultant Services Agreement, dated August 19, 2019 (“First Amendment”); and

WHEREAS, the City and Consultant entered into that certain Second Amendment to Professional Consultant Services Agreement, dated June 30, 2020 (“Second Amendment”); and

WHEREAS, the Agreement is currently going to expire on June 30, 2021; and

WHEREAS, the City has been satisfied with Consultant’s performance under the Agreement and desires to have Consultant continue providing the services referenced in that Agreement; and

WHEREAS, the City and Consultant desire to amend the Agreement to extend the term to June 30, 2022.

NOW, THEREFORE, in consideration of the foregoing recitals which are incorporated herein by this reference, City and Consultant agree as follows:

1. The term of the Agreement is hereby extended to June 30, 2022.
2. All other terms and conditions of the Agreement, First Amendment and Second Amendment between the parties which are not inconsistent with the terms of this Third Amendment shall remain in full force and effect as if fully set forth herein.

IN WITNESS WHEREOF, the parties hereto have caused this Third Amendment to Professional Consultant Services Agreement to be duly executed the day and year first above written.



Orange (Moderate) Tier of California's Blueprint for a Safer Economy on April 7; and (2) authorized the City Manager, or his designee, to amend the Temporary Outdoor Flex Space Permit Program, including making minor and non-substantive changes.

COMPRESSED NATURAL GAS HEAVY-DUTY FREIGHTLINER 114SD DUMP TRUCK - PUBLIC WORKS DIVISION

The City Council approved the purchase of one compressed natural gas heavy-duty Freightliner 114SD dump truck from PB Loader Corporation Fresno, California, in the amount of \$255,084.60 from the Sewer Fund.

COMPRESSED NATURAL GAS VACTOR TRUCK - PUBLIC WORKS ENGINEERING DIVISION - SUPPLEMENTAL APPROPRIATION

The City Council (1) approved the purchase of one compressed natural gas Vactor truck from Haaker Equipment Company La Verne, California, for Public Works Engineering Division in the total amount of \$483,223.28; (2) with at least five affirmative votes, authorized an increase in revenues and supplemental appropriation in the same amount of \$241,611.64 in the National Pollution Discharge Elimination System (NPDES) Storm Drain Fund; (3) with at least five affirmative votes, authorized a supplemental appropriation of \$241,611.64 in the Air Quality Improvement Fund; and (4) authorized the City Manager, or his designee, to execute all documents necessary to complete the purchase, including making minor and non-substantive changes.

AGREEMENT AMENDMENTS - TEMPORARY EMPLOYEE SERVICES

The City Council (1) approved the Third Amendment to the current Professional Consultant Services Agreement with Howroyd-Wright Employment Agency, Inc., (dba Appleone Employment Services), Kimco Staffing Services, Inc., and Peak Technical Services Inc., to provide temporary employment services from July 1, 2021, through June 30, 2022, with the option of two one-year renewals after June 30, 2022, or through June 30, 2024; and (2) authorized the City Manager or his designee to execute the Third Amendment to the Professional Consultant Services Agreement with Howroyd-Wright Employment Agency, Inc., (dba Appleone Employment Services), Kimco Staffing Services, Inc., and Peak Technical Services, Inc., including making minor and non-substantive changes.
