

FOURTH AMENDMENT TO

THIS FOURTH AMENDMENT TO PROFESSIONAL CONSULTANT SERVICES AGREEMENT (“Fourth Amendment”) is made and entered into this 22nd day of June, 2022, by and between the CITY OF RIVERSIDE, a California charter city and municipal corporation (“City”), and PEAK TECHNICAL SERVICES, INC., a Pennsylvania corporation authorized to business in California (“Consultant”), with respect to the following:

**RECITALS**

WHEREAS, the City and Consultant entered into that certain Professional Consultant Services Agreement, dated June 12, 2018 (“Agreement”); and

WHEREAS, the City and Consultant entered into that certain First Amendment to Professional Consultant Services Agreement, dated August 19, 2019 (“First Amendment”); and

WHEREAS, the City and Consultant entered into that certain Second Amendment to Professional Consultant Services Agreement, dated June 30, 2020 (“Second Amendment”); and

WHEREAS, the City and Consultant entered into that certain Third Amendment to Professional Consultant Services Agreement, dated June 2, 2021 (“Third Amendment”); and

WHEREAS, the Agreement is currently going to expire on June 30, 2022; and

WHEREAS, the City has been satisfied with Consultant’s performance under the Agreement and desires to have Consultant continue providing the services referenced in that Agreement; and

WHEREAS, the City and Consultant desire to amend the Agreement to extend the term to June 30, 2023.

NOW, THEREFORE, in consideration of the foregoing recitals which are incorporated herein by this reference, City and Consultant agree as follows:

1. The term of the Agreement is hereby extended to June 30, 2023.
2. All other terms and conditions of the Agreement, First Amendment, Second Amendment, and Third Amendment between the parties which are not inconsistent with the terms of this Fourth Amendment shall remain in full force and effect as if fully set forth herein.


