ORDINANCE NO.

AN ORDINANCE OF THE CITY OF RIVERSIDE, CALIFORNIA, AMENDING CHAPTER 1.12 OF THE RIVERSIDE MUNICIPAL CODE IN ITS ENTIRETY TO ESTABLISH THE BOUNDARIES OF THE SEVEN COUNCILMANIC WARDS IN THE CITY OF RIVERSIDE AS A RESULT OF THE 2020 FEDERAL DECENNIAL CENSUS.

The City Council of the City of Riverside does ordain as follows:

Section 1: Chapter 1.12 of the Riverside Municipal Code is hereby amended in its entirety to read as follows:

WARDS

1.12.010 ESTABLISHED – BOUNDARIES.

There are hereby established in the City seven wards for the election and qualification of members of the City Council which shall be known as the First Ward, Second Ward, Third Ward, Fourth Ward, Fifth Ward, Sixth Ward and Seventh Ward. The boundaries of the respective wards shall be as follows in this Chapter.

1.12.020 FIRST WARD.

The boundaries of the First Ward shall be as follows:

BEGINNING at the centerline intersection of Jurupa Avenue and Tower Road;
Thence northerly and northeasterly along the centerline of Tower Road to the centerline of Rubidoux Avenue;

Thence northwesterly along the centerline of Rubidoux Avenue to the centerline of Tower Road;

1 Thence northeasterly along the centerline of Tower Road to the centerline of Bandini Avenue;
2 Thence southeasterly along the centerline of Bandini Avenue to the centerline of Palm Avenue;
3 Thence northeasterly along the centerline of Palm Avenue to the centerline of Tequesquite
4 Avenue;
5 Thence southwesterly along the centerline of Tequesquite Avenue to the centerline of
6 Rubidoux Avenue;
7 Thence northwesterly along the centerline of Rubidoux Avenue to its intersection with the
8 northwesterly City Limits of the City of Riverside;
9 Thence northeasterly, southeasterly, easterly, southwesterly and northwesterly, along the
10 boundary of the City of Riverside in all its various courses, including those established by legal
11 annexations to the centerline of Interstate 215;
12 Thence southwesterly along the centerline of Interstate 215 to the centerline of Columbia
13 Avenue;
14 Thence easterly along the centerline of Columbia Avenue to the centerline of the Riverside
15 Water Company Canal Right of Way;
16 Thence southwesterly and southerly along the centerline of the Riverside Water Company
17 Canal Right of Way to the centerline of Marlborough Avenue;
18 Thence easterly along the centerline of Marlborough Avenue to the centerline of the Atchison,
19 Topeka and Santa Fe Railroad Right of Way;
20 Thence southwesterly along the centerline of the Atchison, Topeka and Santa Fe Railroad
21 Right of Way to the centerline of Interstate 215/State Route 60;
22 Thence northwest along the centerline of Interstate 215/State Route 60 to the centerline of State
23 Route 91;
24 Thence southwesterly along the centerline of State Route 91 to the centerline of Third Street;
25 Thence southeasterly and easterly along the centerline of Third Street to the centerline of
26 Chicago Avenue;
27 Thence southerly and southeasterly along the centerline of Chicago Avenue to its intersection
28 with the easterly prolongation of the southerly line of Section 25, Township 2 South, Range 5
West, San Bernardino Meridian;
Thence westerly along said easterly prolongation of Section 25 to the southeast corner of said
Section 25;
Thence continuing westerly along said southerly line of Section 25 a distance of 30 feet to the
westerly right of way line of Chicago Avenue;

Thence southerly along said westerly right of way line a distance of 65 feet to a corner of Parcel 3 of a Record of Survey, as shown by map on file in Book 34 of Records of Survey, Page 26 thereof, records of said Riverside County;

Thence southerly, northwesterly and northerly along the northerly line of said Parcel 3 to its re-intersection with said southerly line of Section 25;

Thence westerly along said southerly line of Section 25 to the northeasterly corner of that certain parcel of land described in a Certificate of Compliance issued by the City of Riverside and recorded May 11, 1999, as Instrument No. 202631 Official Records of said Riverside County;

Thence continuing westerly along the northerly line of said parcel of land as described in said Certificate of Compliance to its re-intersection with said southerly line of said Section 25;

Thence continuing westerly along said southerly line of Section 25 to the southwesterly corner thereof;

Thence continuing westerly along the southerly line of Section 26 of said Township 2 South, Range 5 West, San Bernardino Meridian to the centerline of Victoria Avenue;

Thence northerly along the centerline of Victoria Avenue to the easterly prolongation of the northerly line of Parcel 3 of a Certificate of Compliance issued by the City of Riverside and recorded March 7, 1985, as Instrument No. 47123, Official Records of said Riverside County, said Parcel being shown on a Record of Survey on file in Record of Survey Book 84, page 35 thereof, records of said Riverside County;

Thence westerly along said easterly prolongation to the westerly line of Victoria Avenue;
Thence westerly along said northerly line of Parcel 3 and along the northerly line of Parcels 2 and 1 of last said Certificate of Compliance all as shown on said Record of Survey, South 87°44'32" West, a distance of 534.14 feet to an angle point therein;

Thence northwesterly, continuing along said northerly line of Parcel 1, North 65°47'05" West, a distance of 205.11 feet to the northwesterly corner of said Parcel 1 as shown by said Record of Survey;

Thence southerly along the westerly line of said Parcel 1, South 6°18'34" West, a distance of 114.22 feet to the southwesterly corner thereof and the northerly line of Rockledge Park as shown by map on file in Map Book 14, Page 90 thereof, Records of said Riverside County;

Thence northwesterly and westerly along said northerly line of said Rockledge Park to the northwesterly corner of Lot 1 of said Rockledge Park;

Thence southerly along the westerly line of said Lot 1 to its intersection with the northerly line of Rockledge Park No. 3 as shown by map on file in Map Book 21, Page 1 thereof, records of said Riverside County;
Thence westerly along said northerly line of said Rockledge Park No. 3 and its westerly prolongation to the centerline of State Route 91;

1 Thence northerly along the centerline of State Route 91 to the centerline of the Union Pacific
2 Railroad right of way;

3 Thence southwesterly along the centerline of the Union Pacific Railroad right of way to its
4 intersection with the easterly prolongation of the centerline of Jurupa Avenue;

5 Thence westerly along said easterly prolongation and the centerline of Jurupa Avenue to the
6 centerline of Tower Road and the POINT OF BEGINNING.

7 **1.12.030 SECOND WARD.**

8 The boundaries of the Second Ward shall be as follows:

9 BEGINNING at the centerline intersection of State Route 91 and the centerline of Third Street;

10 Thence northeasterly along the centerline of State Route 91 to the centerline of Interstate
11 215/State Route 60;

12 Thence southeast on the centerline of Interstate 215/State Route 60 to the centerline of the
13 Atchison, Topeka and Santa Fe Railroad Right of Way;

14 Thence northeasterly along the centerline of the Atchison, Topeka and Santa Fe Railroad Right
15 of Way to the centerline of Marlborough Avenue;

16 Thence westerly along the centerline of Marlborough Avenue to the centerline of the Riverside
17 Water Company Canal Right of Way;

18 Thence northerly and northeasterly along the centerline of the Riverside Water Company Canal
19 Right of Way to the centerline of Columbia Avenue;

20 Thence Westerly along the centerline of Columbia Avenue to the centerline of Interstate 215;
21 Thence northeasterly along the centerline of Interstate 215 to its intersection with the Northerly
22 City Limits of the City of Riverside;

23 Thence easterly, westerly, southerly, northeasterly, southeasterly, southwesterly and
24 northwesterly, along the boundary of the City of Riverside in all its various courses, including
25 those established by legal annexations to its intersection with the centerline of centerline of
26 Barton Street south of Alessandro Boulevard;

27 Thence northerly along the centerline of Barton Street to the centerline of Alessandro
28 Boulevard;

Thence westerly and northwesterly along the centerline of Alessandro Boulevard to the
centerline of Canyon Crest Drive;

Thence northeasterly and northerly along the centerline of Canyon Crest Drive to the centerline
of Via Vista Drive;

Thence westerly along the centerline of Via Vista Drive to the centerline of Claridge Drive;

1 Thence northerly along the centerline of Claridge Drive to the centerline of Century Avenue;

2 Thence westerly, northwesterly and southwesterly along the centerline of Century Avenue to
3 the centerline of Alessandro Boulevard;

4 Thence northwesterly along the centerline of Alessandro Boulevard to the centerline of
5 Chicago Avenue;

6 Thence northeasterly, northerly and northwesterly along the centerline of Chicago Avenue to
7 the centerline of Third Street;

8 Thence westerly and northwesterly along the centerline of Third Street to the centerline of
9 State Route 91 and to the POINT OF BEGINNING.

10 **1.12.040 THIRD WARD.**

11 The boundaries of the Third Ward shall be as follows:

12 BEGINNING at the centerline intersection of Van Buren Boulevard and the northerly City
13 Limits of the City of Riverside;

14 Thence southerly and southeasterly along the centerline of Van Buren Boulevard to the
15 centerline of Colorado Avenue;

16 Thence northeasterly along the centerline of Colorado Avenue to the centerline of Adams
17 Street;

18 Thence southeasterly along the centerline of Adams Street to the centerline of California
19 Avenue;

20 Thence northeasterly along the centerline of California Avenue to the centerline of Jefferson
21 Street;

22 Thence southeasterly along the centerline of Jefferson Street to the centerline of Magnolia
23 Avenue;

24 Thence northeasterly along the centerline of Magnolia Avenue to the centerline of Hoover
25 Street;

26 Thence southeasterly along the centerline of Hoover Street to the centerline of State Route 91;

27 Thence northeasterly along the centerline of State Route 91 to the centerline of Brockton
28 Avenue;

Thence southeasterly along the centerline of Brockton Avenue to the centerline of Mary Street;

Thence southeasterly along the centerline of Mary Street to the centerline of Victoria Avenue;

1 Thence northeasterly and northerly along the centerline of Victoria Avenue to the centerline
2 of Arlington Avenue;

3 Thence easterly, southeasterly and northeasterly along the centerline of Arlington Avenue to
4 the centerline of Alessandro Boulevard;

5 Thence northeasterly and northerly along the centerline of Chicago Avenue to its intersection
6 with the easterly prolongation of the southerly line of Section 25, Township 2 South, Range 5
7 West, San Bernardino Meridian;

8 Thence westerly along said easterly prolongation of Section 25 to the southeast corner of said
9 Section 25;

10 Thence continuing westerly along said southerly line of Section 25 a distance of 30 feet to the
11 westerly right of way line of Chicago Avenue;

12 Thence southerly along said westerly right of way line a distance of 65 feet to a corner of Parcel
13 3 of a Record of Survey, as shown by map on file in Book 34 of Records of Survey, Page 26
14 thereof, records of said Riverside County;

15 Thence southerly, northwesterly and northerly along the northerly line of said Parcel 3 to its
16 re-intersection with said southerly line of Section 25;

17 Thence westerly along said southerly line of Section 25 to the northeasterly corner of that
18 certain parcel of land described in a Certificate of Compliance issued by the City of Riverside
19 and recorded May 11, 1999, as Instrument No. 202631 Official Records of said Riverside
20 County;

21 Thence continuing westerly along the northerly line of said parcel of land as described in said
22 Certificate of Compliance to its re-intersection with said southerly line of said Section 25;

23 Thence continuing westerly along said southerly line of Section 25 to the southwesterly corner
24 thereof;

25 Thence continuing westerly along the southerly line of Section 26 of Township 2 South, Range
26 5 West, San Bernardino Meridian to the centerline of Victoria Avenue;

27 Thence northerly along the centerline of Victoria Avenue to the easterly prolongation of the
28 northerly line of Parcel 3 of a Certificate of Compliance issued by the City of Riverside and
recorded March 7, 1985, as Instrument No. 47123, Official Records of said Riverside County,
said Parcel being shown on a Record of Survey on file in Record of Survey Book 84, page 35
thereof, records of said Riverside County;

Thence westerly along said easterly prolongation to the westerly line of Victoria Avenue;

Thence westerly along said northerly line of said Parcel 3 and along the northerly line of
Parcels 2 and 1 of last said Certificate of Compliance and all as shown on said Record of
Survey, South 87°44'32" West, a distance of 534.14 feet to an angle point therein;

1 Thence northwesterly, continuing along said northerly line of said Parcel 1, North 65°47'05"
2 West, a distance of 205.11 feet to the northwesterly corner of said Parcel 1 as shown by said
3 Record of Survey;

4 Thence southerly along the westerly line of said Parcel 1, South 6°18'34" West, a distance of
5 114.22 feet to the southwesterly corner thereof and the northerly line of Rockledge Park as
6 shown by map on file in Map Book 14, Page 90 thereof, records of said Riverside County;

7 Thence northwesterly and westerly along said northerly line of said Rockledge Park to the
8 northwesterly corner of Lot 1 of said Rockledge Park;

9 Thence southerly along the westerly line of said Lot 1 to its intersection with the northerly line
10 of Rockledge Park No. 3 as shown by map on file in Map Book 21, Page 1 thereof, records of
11 said Riverside County;

12 Thence westerly along said northerly line of said Rockledge Park No. 3 and its westerly
13 prolongation to the centerline of State Route 91;

14 Thence northerly along the centerline of State Route 91 to the centerline of the Union Pacific
15 Railroad Right of Way;

16 Thence southwesterly along the centerline of the Union Pacific Railroad Right of Way to its
17 intersection with the easterly prolongation of the centerline of Jurupa Avenue;

18 Thence westerly along said easterly prolongation and the centerline of Jurupa Avenue to the
19 centerline of Tower Road;

20 Thence northerly and northeasterly along the centerline of Tower Road to the centerline of
21 Rubidoux Avenue;

22 Thence northwesterly along the centerline of Rubidoux Avenue to the centerline of Tower
23 Road;

24 Thence northeasterly along the centerline of Tower Road to the centerline of Bandini Avenue;

25 Thence southeasterly along the centerline of Bandini Avenue to the centerline of Palm Avenue;

26 Thence northeasterly along the centerline of Palm Avenue to the centerline of Tequesquite
27 Avenue;

28 Thence southwesterly along the centerline of Tequesquite Avenue to the centerline of
Rubidoux Avenue;

Thence northwesterly along the centerline of Rubidoux Avenue to its intersection with the
northwesterly City Limits of the City of Riverside;

Thence southwesterly, northwesterly, southerly, westerly and northerly along the boundary of

8 Thence northeasterly, easterly and southeasterly along the centerline of State Route 91 to
9 centerline of Magnolia Avenue;

10 Thence northeasterly along the centerline of Magnolia Avenue to the centerline of Golden
11 Avenue;

12 Thence northwesterly along the centerline of Golden Avenue to the centerline of Collett
13 Avenue;

14 Thence northeasterly along the centerline of Collett Avenue to the centerline of La Sierra
15 Avenue;

16 Thence northwesterly along the centerline of La Sierra Avenue to the centerline of Hole
17 Avenue;

18 Thence southeasterly along the centerline of Hole Avenue to the centerline of Wells Avenue;

19 Thence northeasterly along the centerline of Wells Avenue to the centerline of Tyler Street;

20 Thence northwesterly along the centerline of Tyler Street to the centerline of Hedrick Avenue;

21 Thence northeasterly along the centerline of Hedrick Avenue to the centerline of Crest Avenue;

22 Thence northwesterly, northeasterly and northerly along the centerline of Crest Avenue to the
23 centerline of Arlington Avenue;

24 Thence easterly along the centerline of Arlington Avenue to the centerline of Van Buren
25 Boulevard;

26 Thence northerly and northwesterly along the centerline of Van Buren Boulevard to its
27 intersection with the northerly City Limits of the City of Riverside;

28 Thence westerly, southwesterly, southerly, easterly and southeasterly along the boundary of
the City of Riverside in all its various courses, including those established by legal annexations
to the centerline of State Route 91 and to the POINT OF BEGINNING.

Section 2: The City Council has reviewed the matter and, based upon the facts and
information contained in the staff reports, administrative record, and written and oral testimony,

1 hereby finds that this ordinance is not subject to CEQA pursuant to Sections 15060(c)(2), 15060(c)(3)
2 and/or 15061(b)(3) of the State CEQA Guidelines, California Code of Regulations, Title 14, Chapter
3 3, in that it will not result in a direct or reasonably foreseeable indirect physical change in the
4 environment nor have a significant impact on the environment.

5 Section 3: The City Clerk shall certify to the adoption of this ordinance and cause publication
6 once in a newspaper of general circulation in accordance with Section 414 of the Charter of the City
7 of Riverside. This ordinance shall become effective on the 30th day after the date of its adoption.
