HEALTH, SAFETY, AND SECURITY UPDATES

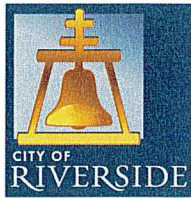

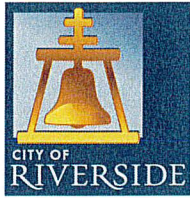
Following discussion, it was moved by Councilmember Cervantes and seconded by Councilwoman Plascencia to (1) approve the Inclusiveness, Community Engagement and Governmental Processes Committee recommendation to adopt a resolution establishing a policy for the proper display and handling of flags at City facilities and for approval and display of commemorative flags; and (2) forward future commemorative flags to the Human Relations Commission for consideration and input. The motion carried with Councilmembers Edwards, Cervantes, Fierro, Hemenway and Councilwoman Plascencia voting aye and Councilmembers Conder and Perry voting no.

Whereupon, the title having been read and further reading waived, Resolution No. 23947 of the City Council of the City of Riverside, California, Establishing a Proper Flag Handling and Display Policy for Flags on all City-Owned or City-Maintained Facilities and for the Display of Commemorative Flags, was presented and adopted.

MASTER FRINGE BENEFITS AND SALARY PLAN AMENDMENT - CALPERS RETIREMENT COST-SHARING - UNREPRESENTED POLICE MANAGEMENT EMPLOYEES - RESOLUTIONS

Following discussion, it was moved by Councilwoman Plascencia and seconded by Councilmember Perry to (1) approve an amendment to the contract between CalPERS and the City of Riverside for the implementation of a cost-sharing provision of 5.5 percent for all Tier 1 and Tier 2 unrepresented Police Management employees in the Police Safety group to pay the employer contribution of five and one-half percent (5.5%) of pensionable income pursuant to Government Code Section 20516 effective as soon as administratively possible; and (2) amend the Master Fringe Benefits and Salary Plan to reflect the CalPERS cost-sharing provisions for Unrepresented Police Management. The motion carried with Councilmembers Edwards, Cervantes, Fierro, Perry, Hemenway and Councilwoman Plascencia voting aye and Councilmember Conder abstaining.

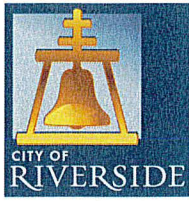

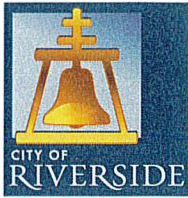

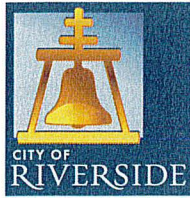

SUBRECIPIENT AGREEMENT - PROGRAMS AND RESOURCES TO HOMELESS INDIVIDUALS RELEASED FROM RIVERSIDE PRESLEY DETENTION CENTER

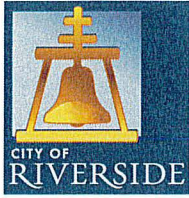
The City Council (1) approved a Subrecipient Agreement for the Homeless Housing, Assistance and Prevention Round 3 with Victory Outreach Church for \$280,216 to connect homeless individuals being released from the Riverside Presley Detention Center to programs and resources; and (2) authorized the City Manager, or designee, to execute the Subrecipient Agreement for the Homeless Housing, Assistance and Prevention Round 3 with Victory Outreach Church, including making any minor, non-substantive changes.

COMMERCIAL LEASE AGREEMENT - MAGNOLIA PLACE SHOPPING CENTER - 10560 MAGNOLIA AVENUE, SUITE C

The City Council (1) approved a City of Riverside Commercial Lease Agreement with Cynthia Ann Bleier, dba Picasso's Colour Studio, Riverside, in the amount of \$2,710.36 per month with 2.5 percent increases annually for the balance of the lease agreement; and (2) authorized the City Manager, or designee, to execute the City of Riverside Commercial Lease Agreement and optional three five-year options to extend including making any minor and non-substantive changes.

BID 7937 - FORD F350 UTILITY TRUCK - POLICE DEPARTMENT SPECIAL OPERATIONS DIVISION

The City Council awarded Bid 7937 to Fritts Ford, Riverside, for the purchase of one current model Ford F350 utility truck for the Police Department Special Operations Division in the total amount of \$75,223.01.

PURCHASE - FORD F350 UTILITY TRUCKS - VARIOUS CITY DEPARTMENTS - SUPPLEMENTAL APPROPRIATION

The City Council (1) approved the purchase of four current model Ford F350 Utility trucks from PB Loader Corporation that will be assigned to various City departments in the total amount of \$504,792.28; and (2) by at least five affirmative votes, authorized a supplemental appropriation in the amount of \$138,100 to Central Garage Fund, General Services Department Motor Pool, Automotive Equipment account from available fund balance.

AGREEMENT - LANDSCAPE MAINTENANCE AND IRRIGATION REPAIR SERVICES - VARIOUS CITY FACILITIES

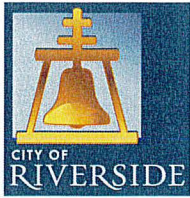
The City Council (1) approved the agreement with BrightView Landscape Services, Inc., for landscape maintenance and irrigation repair services for the term of January 1, 2023, through June 30, 2023, in the amount of \$120,600.23; (2) authorized the City Manager, or designee, to execute the Agreement with BrightView Landscape Services, Inc., including making minor and non-substantive changes; and (3) authorized the City manager or designee to execute a 25 percent change order authority in the amount of \$30,150.06.

MEASURE Z - PURCHASE - FREIGHTLINER 114SD DUMP TRUCKS - PUBLIC WORKS STREET MAINTENANCE DIVISION

Following discussion, it was moved by Councilmember Conder to forward the purchase of three Freightliner 114SD dump trucks from PB Loader Corporation and one Crafcro Super Shot 250 Melter from Crafcro, Inc., for the Public Works Street Maintenance Division in the total amount of \$1,009,990.51 to the Budget Engagement Commission. The motion failed for lack of a second.

Following further discussion, motion was made by Councilwoman Plascencia and seconded by Councilmember Cervantes to approve the purchase of three Freightliner 114SD dump trucks from PB Loader Corporation and one Crafcro Super Shot 250 Melter from Crafcro, Inc., for the Public Works Street Maintenance Division in the total amount of \$1,009,990.51 using Section 602(f) of Purchasing Resolution 23914; and (2) authorized 15 percent change order authority up to \$151,498.58 for equipment cost inflation for a total amount of \$1,161,489.09.
