The minutes of the meeting of April 27, 2023, were approved as presented.

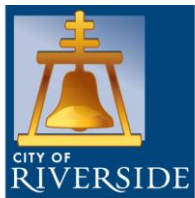
### ATTENDANCE

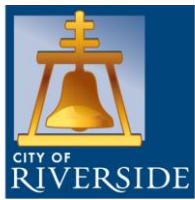
Following discussion, it was moved by Commissioner Barth and seconded by Commissioner Shirley to receive and order filed the report regarding amendments to Riverside Municipal Chapter 2.78 Code of Ethics and Conduct with no recommendations for the Board of Ethics. The motion carried unanimously with Chair Ayra and Commissioner Polichetti absent.

### AMEND CHAPTER 2.16 OF RIVERSIDE MUNICIPAL CODE SECTION 2.16.020, TO REDUCE MEMBERSHIP OF HUMAN RELATIONS COMMISSION

Following discussion, it was moved by Commissioner Lewis and seconded by Commissioner Goe to (1) recommend no changes to Chapter 2.16 Section 2.16.020 of the Riverside Municipal Code to reduce the membership of the Human Relations Commission; and (2) forward the recommendation regarding no changes to the Human Relations Commission membership to the Inclusiveness, Community Engagement and Governmental Processes Committee for consideration. The motion carried unanimously with Chair Ayra and Commissioner Polichetti absent.

### ADDITIONAL COMMISSIONER TO AD HOC COMMITTEE FOR DEVELOPMENT OF A MARKETING CAMPAIGN FOR THE HUMAN RELATIONS COMMISSION

Following discussion, it was moved by Commissioner Barth and seconded by Commissioner Fujimoto to appoint Commissioner German to the Ad Hoc Committee regarding the development of a marketing campaign for the Human Relations Commission in addition to current Ad Hoc Committee members of Chair Ayra, Vice Chair Cavett, Commissioners Shirley, and Fujimoto.
