BACKGROUND (CONTINUED)

- On June 20, 2023 the City Council approved submittal of an application to the USDOT 2023 SS4A Grant Program
- On July 8, 2023 the Public Works Department submitted the grant application with a total grant request of \$11+M
- On December 14, 2023, the USDOT informed the City that it's grant application was successful
- Total Project is \$13.8 M

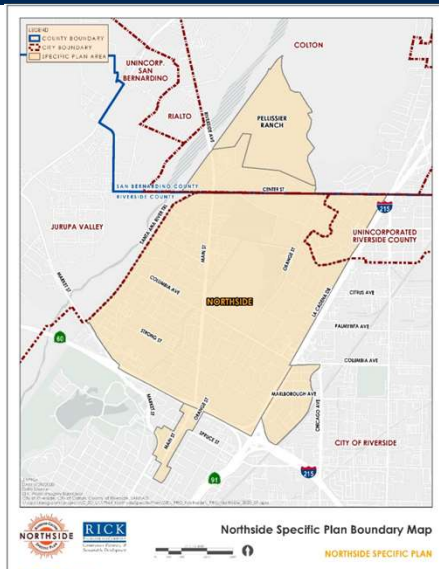

- Total Project Cost \$13.9 Million
- Grant Amount Awarded \$11.1 Million
- Local Match \$ 2.7 Million

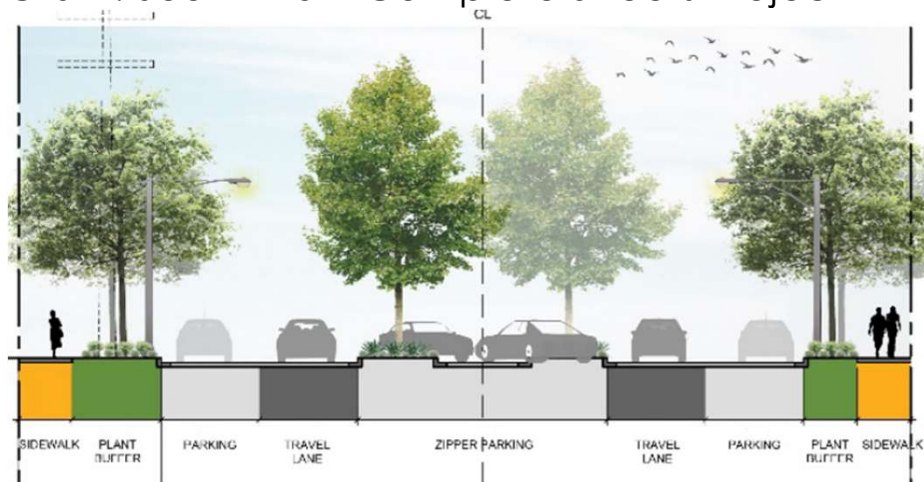

RECOMMENDATIONS

That the City Council:

1. Approve the acceptance of a grant award in the amount of \$11,104,807, under the 2023 Safe Streets For All (SS4A) Program as administered by the United States Department of Transportation (USDOT) for the construction of the South Main Complete Streets Project and the development of citywide supplemental safety action plans; and
2. Authorize the City Manager, or designee, to execute all necessary documents in the process of securing funds under the 2023 Safe Streets For All (SS4A) Program, including making minor and non-substantive changes and executing agreement amendments and extensions, subject to the availability of budgeted funds; and

RECOMMENDATIONS

3. With at least five affirmative votes, authorize the Chief Financial Officer, or designee, to record an increase in grant revenue and appropriate expenditures in the amounts of \$10,784,807 in the Capital Outlay-Grants Fund, South Main Complete Streets Project revenue and expenditure accounts and \$320,000 in the Capital Outlay-Grants Fund, Speed Limit Reduction Project revenue and expenditure accounts; and
4. With at least five affirmative votes, authorize the Chief Financial Officer, or designee, to record a supplemental appropriation in the amounts of \$2,696,202 in the Measure A Fund, South Main Complete Streets expenditure account and \$80,000 in the Measure A Fund, Speed Limit Reduction Project expenditure account, for the City match portion of the grant.
